SUBJECT: MEETING OF THE COMMITTEE ON TRADE AND DEVELOPMENT AND OF THE GROUP ON RESIDUAL RESTRICTIONS

THE COMMITTEE ON TRADE AND DEVELOPMENT WILL HOLD ITS NEXT MEETING FROM 18 TO 21 OCTOBER. THE MEETING WILL OPEN ON TUESDAY, 18 OCTOBER AT 3 P.M., AT THE PALAIS DES NATIONS, GENEVA. AN ANNOTATED PROVISIONAL AGENDA IS BEING CIRCULATED SEPARATELY (COM.TD/M/27).

AT ITS MEETING IN JULY, THE GROUP ON RESIDUAL RESTRICTIONS AGREED THAT IT SHOULD RECONVENE IMMEDIATELY PRIOR TO THE MEETING OF THE COMMITTEE ON TRADE AND DEVELOPMENT TO CONSIDER THE FINDINGS AND RECOMMENDATIONS IT SHOULD SUBMIT IN RESPECT OF THE REMAINING RESTRICTIONS AFFECTING EXCOPTS OF DEVELOPING COUNTRIES. CONSEQUENTLY THE GROUP WILL MEET ON 17 OCTOBER AT 3 P.M., AT THE PALAIS DES NATIONS, GENEVA.

WITH REGARD TO THE LATTER SUBJECT, ATTENTION IS DRAWN TO GATT/AIR/569 INVITING CONTRACTING PARTIES TO GIVE FURTHER CONSIDERATION TO IMPORT LIBERALIZATION MEASURES OR, AS APPROPRIATE, TO THE STEPS THEY WOULD WISH TO PROPOSE FOR DEALING WITH THE PROBLEM OF REMAINING RESTRICTIONS AND TO REPORT THEREON.

MEMBERS OF THE COMMITTEE, MEMBERS OF THE GROUP AND OTHER CONTRACTING PARTIES AND ASSOCIATED GOVERNMENTS WISHING TO BE REPRESENTED BY OBSERVERS AT THESE MEETINGS ARE REQUESTED TO ADVISE ME AS SOON AS POSSIBLE OF THE NAMES OF THEIR REPRESENTATIVES.
