SUBJECT: MEETING OF COUNCIL OF REPRESENTATIVES

A MEETING OF THE COUNCIL OF REPRESENTATIVES WILL BE HELD IN THE PALAIS DES NATIONS AT 11 A.M. ON THURSDAY 17 NOVEMBER.

AT THIS MEETING THE COUNCIL WILL BE ASKED TO CONSIDER THE REPORT OF THE COMMITTEE ON BUDGET, FINANCE AND ADMINISTRATION, WHICH HAS BEEN DISTRIBUTED IN DOCUMENT L/2694. THE RESOLUTION ON REVENUE AND EXPENDITURE IN 1967, ANNEXED TO THE REPORT, IF APPROVED BY THE COUNCIL, WILL BE SUBMITTED TO CONTRACTING PARTIES FOR ADOPTION. BALLOT PAPERS WILL BE DISTRIBUTED AT THE MEETING. IN VIEW OF THE URGENCY OF THE MATTER REPRESENTATIVES ARE SPECIALLY REQUESTED TO OBTAIN AUTHORITY TO VOTE AT THE MEETING ON BEHALF OF THEIR GOVERNMENTS.
