## SUBJECT: COMMITTEE ON BALANCE-OF-PAYMENTS RESTRICTIONS

1. THE NEXT MEETING OF THE COMMITTEE ON BALANCE-OF-PAYMENTS RESTRICTIONS WILL CONVENE IN GENEVA ON 16 OCTOBER 1967. IT IS HOPED TO HOLD MEETINGS MORE OR LESS CONTINUOUSLY UNTIL ABOUT 25 OCTOBER AND THEN TO ADJOURN THE MEETING TO A TIME EARLY IN THE SESSION OF THE CONTRACTING PARTIES (BUT NOT BEFORE 1 NOVEMBER), WHEN THE COMMITTEE COULD RECONVENE FOR THE PURPOSE OF FINISHING UP ANY PREVIOUS BUSINESS AND CONDUCT THE CONSULTATION WITH SOUTH AFRICA.

2. THE TENTATIVE PROGRAMME FOR CONSULTATIONS IS AS FOLLOWS:

FINLAND - 3.00 P.M. ON 16 OCTOBER CHILE - 3.00 P.M. ON 18 OCTOBER INDONESIA - 3.00 P.M. ON 20 OCTOBER TUNISIA - 3.00 P.M. ON 23 OCTOBER SOUTH AFRICA - 1 NOVEMBER OR LATER, TO BE DECIDED

3. BASIC DOCUMENTS FOR THESE CONSULTATIONS ARE BEING OR WILL BE DISTRIBUTED IN THE BOP/SERIES. PAPERS SUPPLIED BY THE ENTERNATIONAL MONETARY FUND WILL BE FORWARDED IN THE USUAL MANNER.

4. MEMBERSHIP OF THE COMMITTEE 25 SHOWN IN L/2248.

5. MEMBERS OF THE COMMITTEE AND THE CONSULTING CONTRACTING PARTIES, AS WELL AS ANY OTHER CONTRACTING PARTIES AND ASSOCIATED GOVERNMENTS WISHING TO BE REPRESENTED BY OBSERVERS AT THESE MEETINGS, ARE REQUESTED TO NOTIFY ME AS SOON AS POSSIBLE OF THE NAMES OF THEIR REPRESENTATIVES.
