SUBJECT: COUNCIL OF REPRESENTATIVES

I HAVE BEEN REQUESTED BY THE GOVERNMENT OF THE UNITED STATES TO CONVENE THE COUNCIL OF REPRESENTATIVES TO CONSIDER THEIR REQUEST THAT A WORKING PARTY BE ESTABLISHED WITH THE FOLLOWING TERMS OF REFERENCE:

IN VIEW OF THE PRESENT BALANCE-OF-PAYMENTS DIFFICULTIES FACED BY A NUMBER OF CONTRACTING PARTIES, AND TAKING INTO ACCOUNT THE EFFECTS OF BORDER TAX ADJUSTMENTS, THE WORKING PARTY SHALL EXAMINE THE RELEVANT GATT RULES AND THE PRACTICES OF CONTRACTING PARTIES UNDER THOSE RULES WITH A VIEW TO RECOMMENDING TO THE CONTRACTING PARTIES SUCH AMENDMENTS OR INTER-PRETATIONS AS THEY FIND TO BE APPROPRIATE.

ACCORDINGLY, I PROPOSE THAT A MEETING BE HELD AT THE PALATS DES NATIONS ON WEDNESDAY 27 MARCH BEGINNING AT 3 P.M.
