SUBJECT: MEETING OF THE GROUP ON RESIDUAL RESTRICTIONS (3-4 OCTOBER)

AT ITS LAST SESSION THE COMMITTEE ON TRADE AND DEVELOPMENT AGREED THAT THE WORK OF THE GROUP ON RESIDUAL RESTRICTIONS SHOULD BE RESUMED. A MEETING OF THE GROUP WILL BE HELD FROM 3 TO 4 OCTOBER. THE MEETING WILL OPEN ON 3 OCTOBER AT 3 P.M. IN SALLE XV, PALAIS DES NATIONS, GENEVA.

A LIST OF IMPORT RESTRICTIONS AFFECTING PRODUCTS OF EXPORT INTEREST TO DEVELOPING COUNTRIES, DRAWN UP ON THE INSTRUCTIONS OF THE COMMITTEE TO SERVE AS A BASIS FOR DISCUSSION IN THE GROUP, HAS BEEN CIRCULATED IN COM.TD/W/76.

MEMBERS OF THE GROUP, CONTRACTING PARTIES MAINTAINING SUCH IMPORT RESTRICTIONS, AS WELL AS OTHER CONTRACTING PARTIES, ASSOCIATED GOVERNMENTS AND INTERGOVERNMENTAL ORGANIZATIONS WISHING TO BE REPRESENTED BY OBSERVERS AT THE MEETING, ARE REQUESTED TO INFORM ME AS SOON AS POSSIBLE OF THE NAMES OF THEIR REPRESENTATIVES.
