SUBJECT: MEETING OF COMMITTEE ON TRADE IN INDUSTRIAL PRODUCTS

1. THE CHAIRMAN OF THE COMMITTEE ON TRADE IN INDUSTRIAL PRODUCTS HAS DECIDED TO CONVENE THE COMMITTEE FOR THE PURPOSE OF DISCUSSING THE FURTHER ORGANIZATION OF ITS WORK ON THE INVENTORY OF NON-TARIFF BARRIERS, INCLUDING THE QUESTION OF ESTABLISHING WORKING GROUPS OF THE COMMITTEE.
