SUBJECT: COMMITTEE ON TRADE AND DEVELOPMENT EXAMINATION OF OPERATION OF PART IV

- 1. AT ITS LAST SESSION, HELD ON 3-5 JUNE, THE COMMITTEE ON TRADE AND DEVELOPMENT AGREED THAT IT WOULD ENTER INTO A DETAILED AND SUBSTANTIVE EXAMINATION OF THE OPERATION OF PART IV AT ITS NEXT SESSION, TO BE HELD LATER THIS YEAR. IN THE MEANTIME, MEMBERS OF THE COMMITTEE WOULD CONTINUE INFORMAL CONSULTATION WITH A VIEW TO DECIDING UPON THE MOST PRACTICAL MANNER AND THE MOST SUITABLE MECHANISMS FOR CARRYING FORWARD THIS EXAMINATION (CF. COM.TD 60, PARAGRAPH 11).
- 2. IN PREPARATION FOR THAT DISCUSSION THE COMMITTEE AGREED THAT THE STATEMENTS WHICH HAD BEEN MADE BY CONTRACTING PARTIES OF THIS SUBJECT, TOGETHER WITH ALL RELEVANT BACKGROUND MATERIAL AND RECORDS OF MAST DISCUSSIONS, SHOULD BE CONVEYED TO GOVERNMENTS FOR CONSIDERATION AS SOON AS POSSIBLE. IN THIS CONNEXION ATTENTION IS INVITED TO THE FOLLOWING DOCUMENTS:

IT WAS ALSO AGREED IN THE COMMITTEE THAT DEVELOPED COUNTRIES AND DEVELOPING COUNTRIES WHICH HAD NOT SUBMITTED STATEMENTS SHOULD ENDEAVOUR TO SUPPLY THE COMMITTEE WITH THEIR VIEWS AND PROPOSALS AS SOON AS POSSIBLE. TO THE EXTENT POSSIBLE THE FURTHER STATEMENTS FROM GOVERNMENTS SHOULD REFER TO SPECIFIC INSTANCES OR SITUATIONS INVOLVING APPARENT NON-COMPLIANCE WITH THE PROVISIONS OF PART IV. IT WOULD BE MOST HELPFUL IF ANY NEW SUBMISSIONS OF THIS KIND FROM GOVERNMENTS COULD BE MADE AVAILABLE TO THE SECRETARIAT AS SOON AS POSSIBLE AND NOT LATER THAN MID-SEPTEMBER.
