SUBJECT: MEETING OF THE WORKING PARTY ON TRADE ARRANGEMENTS BETWEEN INDIA, THE UNITED ARAB REPUBLIC AND YUGOSLAVIA

1. THE SECOND MEETING OF THE WORKING PARTY WILL BEGIN ON THURSDAY, 18 DECEMBER 1969, AT 10 A.M. IN THE PALAIS DES NATIONS.
2. THE PURPOSE OF THE MEETING IS TO GIVE THE WORKING PARTY AN OPPORTUNITY
  - (a) TO CONTINUE THE CONSULTATION WITH THE THREE COUNTRIES CONCERNED REGARDING THE PROTOCOL OF 16 JULY 1969 AMENDING THE TRADE EXPANSION AND ECONOMIC CO-OPERATION AGREEMENT OF 23 DECEMBER 1967;
  - (b) TO CARRY OUT THE REVIEW OF THE DECISION OF 14 NOVEMBER 1968 AS PROVIDED IN PARAGRAPH 1(c) OF THE DECISION; AND
  - (c) TO MAKE A REPORT TO THE COUNCIL.
