SUBJECT: WORKING PARTY ON EEC ASSOCIATION WITH AFRICAN AND MALAGASY STATES

THE TEXT OF THE NEW CONVENTION OF ASSOCIATION CONCLUDED BETWEEN THE EEC AND THE AFRICAN AND MALAGASY STATES ON 29 JULY 1969 WAS DISTRIBUTED TO CONTRACTING PARTIES IN DOCUMENT L/3283. THE COUNCIL OF REPRESENTATIVES AT ITS MEETING ON 22-23 JANUARY 1970 ESTABLISHED A WORKING PARTY TO EXAMINE THE PROVISIONS OF THE CONVENTION IN THE LIGHT OF THE RELEVANT PROVISIONS OF THE GENERAL AGREEMENT.

CONTRACTING PARTIES WISHING TO SUBMIT QUESTIONS TO THE PARTIES TO THE CONVENTION CONCERNING THE PROVISIONS OF THE AGREEMENT ARE REQUESTED TO FORWARD THESE TO THE SECRETARIAT BY 28 FEBRUARY.

THE DATE FOR THE MEETING OF THE WORKING PARTY WILL BE COMMUNICATED IN DUE COURSE.
