SUBJECT: EEC AGREEMENT WITH ISRAEL

1. AT ITS MEETING ON 29 SEPTEMBER 1970, THE COUNCIL ESTABLISHED A WORKING PARTY WITH THE FOLLOWING TERMS OF REFERENCE: "TO EXAMINE IN THE LIGHT OF THE RELEVANT PROVISIONS OF THE GENERAL AGREEMENT THE PROVISIONS OF THE AGREEMENT BETWEEN THE EUROPEAN ECONOMIC COMMUNITY AND THE STATE OF ISRAEL OF 29 JUNE 1970 AND TO REPORT TO THE COUNCIL."
2. CONTRACTING PARTIES WISHING TO PUT QUESTIONS REGARDING THE PROVISIONS OF THE AGREEMENT IN ACCORDANCE WITH THE USUAL PROCEDURE ARE INVITED TO SUBMIT THESE QUESTIONS TO THE SECRETARIAT BEFORE 15 NOVEMBER.
3. AT THE MEETING OF THE COUNCIL CONTRACTING PARTIES WISHING TO BE MEMBERS OF THE WORKING PARTY WERE INVITED TO INFORM THE SECRETARIAT. THE SECRETARIAT WOULD APPRECIATE RECEIVING SUCH NOTIFICATIONS BY 15 NOVEMBER.
