SIMILARLY, ADOPTION BY FORMAL VOTE BEFORE THE END OF THE YEAR WILL BE NECESSARY IN RESPECT OF ITEM 1 - CEYLON WAIVER AND ITEM 2 - DECISION TO INVITE TUNISIA TO PARTICIPATE IN THE WORK OF THE CONTRACTING PARTIES.

COUNCIL MEMBERS ARE REQUESTED TO INFORM ME BY 1 DECEMBER OF THE COMPOSITION OF THEIR DELEGATIONS. CONTRACTING PARTIES AND ASSOCIATED GOVERNMENTS NOT MEMBERS OF THE COUNCIL AND INTERGOVERNMENTAL ORGANIZATIONS DESIRING TO BE REPRESENTED BY OBSERVERS SHOULD INFORM ME OF THE NAMES OF THEIR REPRESENTATIVES.
