1. THE NEXT MEETING OF THE COMMITTEE ON TRADE IN INDUSTRIAL PRODUCTS WILL BE HELD ON 23 MARCH AT 10 A.M. IN THE PALAIS DES NATIONS. THE MEETING IS EXPECTED TO LAST THROUGH 24 MARCH.
