## SUBJECT: COMMITTEE ON TRADE IN INDUSTRIAL PRODUCTS

- 1. THE NEXT MEETING OF THE COMMITTEE ON TRADE IN INDUSTRIAL PRODUCTS WILL BE HELD FROM 16 TO 20 OCTOBER IN THE GOVERNING BODY ROOM AT THE INTERNATIONAL LABOUR OFFICE. MEETINGS OF THE COMMITTEE AND THE WORKING PARTY ON TRADE IN TEXTILES, WHICH IS ALSO SCHEDULED TO MEET DURING THIS PERIOD, WILL NOT BE HELD SIMULTANEOUSLY. THE MEETING WILL BEGIN AT 10.30 A.M. ON 16 OCTOBER.
- 2. AS NOTED IN THE SECRETARIAT SUMMARY OF THE NAIN POINTS RAISED AT ITS LAST MEETING (COM.IND/W/87, PARAGRAPH 14), THE COMPUTEE AGREED THAT AT THIS MEETING IT WILL,
  - (a) EXAMINE THE NOTE ON TECHNIQUES AND MODALITIES CONTAINED IN ANNEX I OF COM.IND/W/87,
  - (b) EXAMINE THE IMPLICATIONS FOR DEVELOPING COUNTRIES OF VARIOUS SUGGESTED TECHNIQUES AND MODALITIES WITH THE AID OF THE NOTE BY THE SECRETARIAT (COM. IND/W/85),
  - (c) EXAMINE THE ADEQUACY OF EXISTING SAFEGUARD PROVISIONS WITH THE AID OF THE FACTUAL NOTE BY THE SECRETARIAT (COM.IND/W/88),
  - (d) EXAMINE THE QUESTION OF REFERRING FURTHER TOPICS TO THE WORKING GROUPS WITH A VIEW TO THE STABLISHMENT OF AD REFERENDUM SOLUTIONS (COM.IND/W/87, PARAGRAPHS 11 TO 13), AND
  - (e) DRAW UP ITS PEPORT TO THE COUNCIL
- 3. MEMBERS OF THE COLMETTEE AND CONTRACTING PARTIES, ASSOCIATED GOVERNMENTS AND INTERGOVERNMENTAL ORGANIZATIONS WISHING TO BE REPRESENTED BY OBSERVERS AND NON-GATT DEVELOPING COUNTRIES HAVING NOTIFIED THEIR WISH TO BE ASSOCIATED WITH THE PREPARATORY WORK FOR THE TRADE NEGOTIATIONS ARE REQUESTED TO INFORM ME AS SOON AS POSSIBLE OF THE NAMES OF THEIR REPRESENTATIVES WHO WILL ATTEND THE MEETING.
