SUBJECT: MEETING OF THE COMMITTEE ON TRADE AND DEVELOPMENT

THE TWENTY-FOURTH SESSION OF THE COMMITTEE ON TRADE AND DEVELOPMENT WILL TAKE PLACE ON 29-30 MARCH 1973, BEGINNING AT 10.30 A.M. ON 29 MARCH IN THE PALAIS DES NATIONS, GENEVA.

AS SUGGESTED BY THE CHAIRMAN AT THE TWENTY-THIRD SESSION OF THE COMMITTEE HELD IN FEBRUARY 1973, THE COMMITTEE IS EXPECTED TO TAKE UP AT THE FORTHCOMING MEETING MAINLY THE QUESTION OF IMPORT RESTRICTIONS AND OTHER NON-TARIFF MEASURES. AN ANNOTATED AGENDA WILL BE ISSUED SHORTLY.

MEMBERS OF THE COMMITTEE AND OTHER CONTRACTING PARTIES, ASSOCIATED GOVERNMENTS, INTERGOVERNMENTAL ORGANIZATIONS WISHING TO BE REPRESENTED BY OBSERVERS AND NON-GATT DEVELOPING COUNTRIES HAVING NOTIFIED THEIR WISH TO PARTICIPATE IN THE PREPARATORY WORK FOR THE TRADE NEGOTIATIONS ARE REQUESTED TO ADVISE ME AS EARLY AS POSSIBLE OF THE NAMES OF THEIR REPRESENTATIVES.
