Note by the Secretariat

Addendum

1. In its Report (1984) (BISD 31S/211), adopted by the CONTRACTING PARTIES at their fortieth session, the Group on Quantitative Restrictions and Other Non-Tariff Measures recommended that the documentation on quantitative restrictions be kept up-to-date on a regular basis through notifications by contracting parties maintaining the measures (paragraph 44(a)).
2. In its Report (1986) (L/6073, paragraph 28), adopted by the CONTRACTING PARTIES at their forty-second Session in their Decision establishing the Technical Group (L/6100), the Group on Quantitative Restrictions and Other Non-Tariff Measures called upon contracting parties to supply to the secretariat before 31 January 1987 information lacking in the documentation, including full GATT justification for the measures that they maintain. It also requested them to inform the secretariat by the same date of any specific amendments they wished it to make to the existing basic documentation and analyses.
3. This document contains information additional to that included in NTM/W/6/Rev.3 and Rev.3/Add.1-6. It is organized as follows:
 - I. Amendments to the country notes relating to Canada, Sweden and United States.
 - II. Table of quantitative restrictions: up-dated information relating to Canada and Sweden.
