MEETING OF 10-12 OCTOBER 1988

Note by the Secretariat

1. The Group held its eleventh meeting from 10 to 12 October 1988 under the Chairmanship of Ambassador Julio A. Lacarte-Muró (Uruguay). The Group adopted the agenda set out in GATT/AIR/2681, following agreement to add to this agenda two papers distributed on 10 October 1988, a Revision of a "Communication from Mexico", circulated as document MTN.GNG/NG13/W/26/Rev.1, and a "Dispute Settlement Proposal" made on behalf of a group of countries, circulated as document MTN.GNG/NG13/W/30.

Continuation of consideration of submissions

The Group had before it the revised "Communication from Mexico" 2. (MTN.GNG/NG13/W/26/Rev.1), the "Dispute Settlement Proposal" made on behalf of a group of countries (MTN.GNG/NG13/W/30), and two notes prepared by the Secretariat, entitled "Comparison of Existing Texts and Proposals for Improvements the GATT Dispute Settlement to System" (MTN.GNG/NG13/W/29/Rev.1) and "Differential and More Favourable Treatment Developing Countries in the GATT Dispute Settlement System" of (MTN.GNG/NG13/W/27/Rev.1).

3. In informal session, the Group proceeded to discuss the revised Mexican paper and the proposal made on behalf of a number of countries. It was agreed that the Chairman would draw on these submissions and the detailed discussions relating thereto in preparing a draft Chairman's paper for circulation to the Group prior to its next meeting. It was further agreed that the Chairman's paper would be in the nature of a comprehensive proposal for improvements to existing GATT dispute settlement rules and procedures, to be accompanied by a recommendation that the proposal be adopted by the Ministers at the Mid-Term Review and implemented on a trial basis as of 1 January 1989.
