# Condensed Notice for Air Travellers

SCOPE	<p>Under US law, US Customs and Border Protection (CPB) will receive certain travel and reservation information about all passengers flying between the European Union and the US.</p>
PERSONAL INFORMATION	<p>CBP will receive Passenger Name Record (PNR data) from airlines, including information provided during the booking process or held by airlines or travel agents.</p>
USES	<ul style="list-style-type: none"><li>• CBP has undertaken that it uses PNR data for the purposes of preventing terrorism and other transnational serious crimes.</li><li>• The information will be retained for at least three years and six months.</li><li>• It may be shared with other authorities.</li></ul>
YOUR RIGHTS	<p>These arrangements include measures to safeguard your personal data, including the right to request a copy of your PNR data held in CPB databases and to make corrections.</p>
IMPORTANT INFORMATION	<p>Frequently Asked Questions and other information about these arrangements can be obtained from your airline or travel agent or from the Data Protection Authority in your country.</p>
