

# NM Wildfire and Home Insurance Resources

## Current Status & Updates on New Mexico FAIR Plan

When homeowners have exhausted all other options for insuring their property in high wildfire risk areas, the NM Fair Access to Insurance Requirements (FAIR) Plan will provide coverage for up to \$350K per residential parcel and up to \$1M per commercial property.
