Let's look at the original rejection letter dated 8/15/13 (copy enclosed) from Paulette Edwards of the Central Florida Urban League. She wrote that I was denied because "We could not validate the inappropriate and unethical business practices you claimed of your former employer. It is our position that your status of unemployment is not a qualifying hardship...." I never "claimed" that of my former employer although I did state that 2 pending Federal investigations might find that of interest. I specifically wrote in the complaint letter to Ms Andujar that my former employers actions appeared to be legal. But that's the decision of 2 Federal Agencies who have the authority to make that determination....not Florida Hardest Hit. That would be a concern if I used that as an excuse to quit but I didn't quit. I was terminated through no fault of my own. The copy of the termination letter is enclosed. Now, through Hardest Hit guidelines, I'm unemployed and can't find employment. Is this why I was denied by subsequent reviews of old files?

Dear Ms. Andujar:

This letter has taken me a long time to compose and recompose because of my feelings of anger, betrayal, confusion and the Florida Housing Coalition wasting my time during a time of great stress during the past 11 months.

The letter dated August 29 that you sent me via email has my name and address on it but the content has so many errors that I question if it was meant to be sent to me.

Let's first discuss the phone conversation that we had prior to your sending the letter:

When I asked if you had received the updated material explaining how Kovack Securities cancellation of my contract equaled them firing me through no fault of my own (more on this later) you said brusquely, "yes, so get another contract" as you changed the subject and kept on talking. You would not have made such a rude and hurtful comment if you had reviewed the content because you said the same as "yes, so get another job" which I have been unable to do. When I asked if you received the updated info. on why I don't receive unemployment compensation you said "yes, but I have to check with someone else on that" and then said that if I'm approved it would mean a lot of financial paperwork with the bank and then abruptly ended the conversation saying I'd hear from you.

Everyone can sometimes be over stressed from work or have a bad day. I'm sorry that yours happened while I was trying to work with you.

The email ineligible letter:

Let's start at the bottom where you wrote that questions about my Hardest Hit application should be addressed to Lainie Lowery at the Florida Housing Financing Corporation. When I called the number you gave me, the woman who answered asked me to ID myself, which I did. She stated that I "should not be calling this number because we don't accept calls from the public." When I explained that I'm not public and read the instructions in the letter she curtly replied "We don't.....public" After a 2nd attempt to converse she again repeated """public' and told me if I had questions I need to call my counselor and I should also go to the website for hardest hit help...... THE VERY SITE THAT I FIRST OPENED OVER 11 MONTHS AGO.

You wrote that I "also received a preliminary review by the Florida Housing Finance Corp. and was determined ineligible." That means they didn't review any updated material before making me ineligible. Am I a preliminary human with a preliminary home? Is this the same Florida Housing Finance Corp. that granted Hardest Hit funds to dozens of people who earn over \$90,000 per year? Is this the same FHFC that granted Hardest Hit funds to dozens who lied on their applications or had prior convictions for things such as fraud or child porn? I have documented records of reporting crime to appropriate state and federal agencies. The Florida Housing Coalition has documented records of embracing criminals and felons. It's no wonder that they won't accept phone calls. Is this really the agency that influenced you to decline me when you hadn't fully read my files?

"Your prior employment....no one document can show that the reduction in income was through no fault of your own." WHAT? That means that you did not read or could not comprehend the updated material on "cancelled contract" material I submitted. (still more on that later)

Let's look at some of the things that will show the reduction was through no fault of my own:

I've worked with teachers for 30 years.

I received a letter of commendation from President Reagan for work with inner city youth. I didn't just sit on some committee but worked hundreds of hours in hundreds of classrooms and assemblies interacting face to face with thousands of students. I was a Chicago south side community organizer while President Obama was still in school.

I've been a Registered Representative/Stockbroker/Financial Advisor for almost 30 years. I've never had a client complaint which is rare in this business for that amount of time.

I obtained my M.B.A.

I studied for 2 years of courses and exams to become a Certified Financial Planner ® 28 years ago and have maintained the required continuing education exams for all of the above.

Last year the Chicago teachers went on strike to protect their rights for the first time in 25 years. 26 years ago I walked the line with the Chicago teachers and was awarded an honorary membership in the Chicago Teachers Union.

Last year I was asked to speak at the memorial luncheon for my late friend, Marion Cannon who was the retired president of the Orange County Classroom Teachers Association.

For the last 8 years I have served on a School Advisory Council at a school for troubled students.

I'd give you the website but instead, Google: "Bill Ring, CFP" click About Us.

I have \$\\$hundreds of updated promotional material gathering dust in a storeroom that I can't use because I was fired thru no fault of my own. If you can use a mouse pad or a pen let me know and I'll mail it to you.

Now comes the part about cancelled contract that I've mentioned several times.

I had previously sent a 6 or 7 page email addressed to Brian Kovack. If you don't have it let me know and I'll send it again. The email requested guidance on how to deal with criminals who were stealing my clients, my cash flow, my income. Brian is the president of Kovack Securities who said he'd review it and get back to me but I never heard from him again. It turns out that Brian was receiving payments from one of the crooked companies who sponsor Kovack events. Brian also had under contract a top producing salesman from a crooked company where Brian received override commissions. Brian also is an elected official whose votes come from some of the crooked companies. It appears that Brian has done nothing illegal but he decided to keep the easy money, commissions and votes by hiding from the potential problems. Brian is not aware of 2 federal investigations that are currently taking place. Brian has distanced himself but may be caught up in ethics violations. As I've said before the legal investigations have nothing to do with Hardest Hit and I'm clean

as a whistle. Brian, in an attempt to distance himself from potential problems pretends he knows nothing about it and fired the 2 people who do know; a compliance officer and me except in my case, it's worse because he cancelled my contracts.....not just with Kovack, but with every financial company that I did work with.

Now, I had previously offered instructions, stating that the site would not allow printing or forwarding to prove that I was not only fired without cause but that I cannot work in the industry that I've worked in for the past 30 years because although other companies want me, by law they can't hire me because my credit is now so bad, including my home in foreclosure.

To make it easy go to www.finra.org .click on right icon "Broker Check" click "individual" and follow directions. When screen shows enter name, enter Ronald Giovino Jr Click "full report" Now scroll up and down to view his work history, employment record, licenses and criminal history, etc.

Now click new search and enter William Harold Ring. There's no place to scroll because I'm no longer in the industry. It is now illegal for me to conduct securities sales like I've done for 30 years. Brian Kovack not only fired me through no fault of my own, he stomped on me.

O.K. I've let off some steam and proved some things. So now let's all be friends and get back on track. I've reviewed the Hardest Hit program several times and with work associates and two attorneys we are all in agreement that I qualify for the program. I assume you feel the same. I am begging you that, if you still have a question, that you call, fax or email me. I will provide an answer to your satisfaction with documentation. If necessary, I will come to Tallahassee and answer your questions while hooked up to a polygraph machine. I'm not kidding.

Otherwise, can we please get started on the paperwork to get the Hardest Hit program rolling.
