

INTERAGENCY Memorandum of Understanding (MOU)

Between

Eastern Area Coordinating Group

And

Southern Area Coordinating Group

I. Purpose.

The purpose of this MOU is to set out in general terms the process for the sharing of resources between the Eastern and Southern Geographic Areas.

II. Introduction.

Fire management in the Eastern and Southern Geographic Area's wildlands continues to be a matter of concern to the public and to the land management Bureaus of the Department of Interior; the Department of Agriculture, Forest Service; State of Arkansas Department of Natural Resources; State of Illinois Department of Natural Resources; State of Indiana Department of Natural Resources; State of Kentucky Department of Natural Resources; State of Missouri Department of Conservation; State of Ohio Department of Natural Resources; State of Oklahoma Department of Natural Resources; State of Tennessee Department of Natural Resources; State of Virginia Department of Natural Resources; State of West Virginia Department of Natural Resources, hereafter called the "agencies". Considerable progress has been made in fire management planning and prescribed fire and fire suppression by all agencies. More progress can be made by closer cooperation and coordination among the agencies.

III. Authority.

IV. Objectives.

It is the desire of the Eastern Area (EACG) and Southern Area (SACG) Coordinating Groups to improve the efficiency and cost effectiveness of firefighting efforts by increasing the availability and mobility of firefighting resources across the boundary between the two geographic areas. This MOU provides the authority to directly utilize the resources of adjoining units across the Eastern/Southern geographical areas boundaries for suppression, prescribed fire and other appropriate events. National resources, as described in the National Interagency Mobilization Guide, require the prior approval of the sending Geographic Area Coordination Center. Type 3 helicopters, crews and RX Modules also require the prior approval of the sending Geographic Area Coordination Center when requested for a prescribed fire incident. Either Geographic Area Coordination Center can suspend this MOA during periods of high activity in line with the Neighborhood/GACC Boundary Authority described in both Geographic Area Mobilization Guides.

- a. Utilization of the MOU is valuable when resources may not be able to commit to a 14-day assignment but can assist neighbors for a negotiated shorter period of time.
 - b. During the performance of this MOU, the participants agree to abide by the terms of Executive Order 11246 on non-discrimination and will not discriminate against any person because of race, color, religion, sex or national origin. The participants will take affirmative action to ensure the applicants area employed without regard to their race, color religion, sex, or national origin.
 - c. Each party to this MOU does hereby expressly waive all claims against the other party for compensation for any loss, damage, personal injury or death occurring in consequence in the performance of this MOU.
 - d. This MOU supersedes any MOU's the participating agencies may have with each other.
