INSTRUCTIONS

This application is for any Category 2, 3 or 4 Licensee seeking to obtain a Casino Simulcasting Permit from the Pennsylvania Gaming Control Board (Board) as set forth in 4 Pa C.S. §13F01 – 13F44 of the Pennsylvania Race Horse Development and Gaming Act.

COMPLETING THIS FORM:

1. The applicant must make accurate statements and include all material facts. Any misrepresentation, falsification or omission or the failure to provide requested information, may result in the denial of your application by the Board.
2. All entries on this form, except initials and signatures, must be typed or printed in block lettering using dark ink. If the form is not legible, it will not be accepted.
3. If the applicant makes any modification to the pre-printed questions or information contained in this form, the application will be rejected. Once the application is accepted, it becomes the property of the Board and will not be returned.
4. The original and one paper copy of the application must be sent to the Pennsylvania Gaming Control Board, Bureau of Licensing, 303 Walnut Street, Fifth Floor, Commonwealth Tower, Harrisburg, Pennsylvania 17101.
5. Retain a completed copy of the application package for your own records.
6. A license, permit, certification or registration issuance, renewal or other approval issued by the Board is a revocable privilege. No person holding a license, permit, certification or registration, renewal, or other approval is deemed to have any property rights related to the license, permit, certification or registration, renewal or other approval.

APPENDICES

Appendix 1: Name and business address, job title and a photograph of each principal and key employee who will be involved in the conduct of casino simulcasting and who is not currently licensed by the Board or the Pennsylvania State Horse Racing Commission.

Appendix 2: The estimated number of full-time and part-time employment positions that will be created at the licensed facility if casino simulcasting is authorized. Include an updated hiring plan under 4 Pa.C.S. § 1510(A) which outlines the applicant’s plan to promote the representation of diverse groups and Commonwealth residents in the employment positions.

Appendix 3: A brief description of the economic benefits expected to be realized by the Commonwealth, the Department of Agriculture and the race horse industry in this Commonwealth if casino simulcasting is authorized at the applicant’s licensed facility.

Appendix 4: The details of any financing, if applicable, obtained or that will be obtained to fund an expansion or modification of the licensed facility to accommodate casino simulcasting or to construct a simulcasting facility or to otherwise fund the cost of commencing casino simulcasting operations.

Appendix 5: Information and documentation concerning financial background and resources to establish by clear and convincing evidence the financial stability, integrity and responsibility of the applicant.

Appendix 6: A copy of or a detailed description of the terms and conditions of any agreement(s) the applicant has entered into or will enter into with a licensed racing entity to facilitate the conduct of casino simulcasting.

Appendix 7: A detailed description of any financial arrangements between the applicants and a licensed racing entity related to the conduct of casino simulcasting.

Appendix 8: Detailed site and architectural plans of the proposed simulcasting facility within the applicant's licensed facility.

Appendix 9: A statement demonstrating compliance with the Interstate Horse Racing Act of 1978.

ADDITIONAL INFORMATION

Additional information must be provided to the Board as requested. Upon request of the Board or board staff, the applicant shall cooperate and provide supplemental information in support of its application. The applicant shall provide requested documents, records, supporting data and other information within the time period specified in the request, or if no time is specified, within 30 days of the date of the request. If the applicant fails to provide the requested information within the required time period, the Board may deny the application.

The application and related materials that have been submitted to the Board will become the property of the Board and will not be returned to the applicant.

The Chief Executive Officer ("CEO") or authorized signatory hereby affirms that the applicant currently holds a Category 2, 3 or 4 license in good standing with the Board and that there have been no material changes in circumstances relating to the gaming entity license. The CEO/authorized signatory hereby further affirms that the information provided herein is true and correct and that there is no misrepresentation, falsification or omission in the application. Further, the CEO/authorized signatory is aware that any false or misleading statement or omitted information will be cause for rejection or revocation of a license, registration, certificate or permit and may be subject to criminal penalties under 18 Pa.C.S. § 4902, 4903 and 4904.
