_____	<b>HB 303</b>	<b>HENSGENS</b>	<b>MTR VEHICLE/TRUCK REGS</b> Provides with respect to overhang for trucks and trailers hauling heavy equipment
_____	<b>HB 370</b>	<b>THOMPSON, J</b>	<b>MOTORVEHICLES</b> Prohibits drivers from using certain cellular devices while traveling through school zones during effective hours

_____	<b>HB 1005</b>	<b>ANDERS</b>	<b>MTR VEHICLE/DRIVER LIC</b> Exempts drivers' who possess valid military licenses from the knowledge and skills test requirements to obtain a Class "A", "B", and "C" commercial driver's license
