HCR 26	BURNS, HENRY	PUBLIC HEALTH Urges and requests the Louisiana State Law Institute to study and make recommendations concerning gun ownership rights of persons who have attempted suicide
HB 10	BURNS, HENRY	WEAPONS/FIREARMS Provides relative to the exemption for law enforcement officers regarding the carrying of weapons in alcoholic beverage outlets
HB 17	LOPINTO	WEAPONS/FIREARMS Provides relative to the illegal possession of stolen firearms
HB 20	THOMPSON, J	WEAPONS/FIREARMS Provides relative to the possession of firearms by concealed handgun permit holders in certain alcoholic beverage establishments
HB 72	LOPINTO	WEAPONS/FIREARMS Provides relative to the possession of firearms by concealed handgun permit holders and law enforcement officers in certain alcoholic beverage establishments
HB 160	ST. GERMAIN	EXPLOSIVES Adds binary exploding targets to the definition of explosives
HB 210	JEFFERSON	PAROLE Amends eligibility criteria for medical parole
HB 413	HARRISON	PARDON/PAROLE Provides with respect to parole eligibility
HB 679	JACKSON, K	CRIMINAL/SENTENCING Provides relative to the policies, duties, powers, and reports of the Louisiana Sentencing Commission
HB 681	JACKSON, K	PROBATION Amends the definition of "technical violation" for the purposes of imposition of administrative sanctions and probation violations
HB 682	JACKSON, K	CRIMINAL/SENTENCING Provides relative to parole for persons convicted of certain crimes of violence and provides for the creation and administration of the Programs to Reduce Recidivism Fund

HB 683	JACKSON, K	COURTS Amends eligibility requirements for participation in drug courts and provides relative to annual evaluations of drug courts
HB 732	JACKSON, K	CRIMINAL/PROCEDURE Authorizes the waiver of minimum mandatory sentences for certain sex offenses and crimes of violence
HB 734	JACKSON, K	CRIMINAL/SENTENCING Provides relative to ameliorative penalty provisions
HB 791	JACKSON, K (TBA)	CRIME/THEFT Amends the crime of theft and repeals statutes relative to theft of certain things (Subject to Rule Suspension)
HB 1024	JACKSON, K	CONTROLLED SUBSTANCES Provides with respect to drug free zones
HB 1038	DIXON	CRIMINAL/PROCEDURE Extends the period in which to file an application for DNA testing
