_____	HB 92	CONNICK	TAX/AD VALOREM TAX (Constitutional Amendment) Increases the income limit for qualification for the special assessment level for property subject to ad valorem tax
_____	HB 420	PEARSON	TAX/AD VALOREM TAX Establishes criteria for valuation of low-income housing property for purposes of assessment of ad valorem taxes
_____	HB 465	BROADWATER	TAX/AD VALOREM TAX Provides with respect to ad valorem taxes on shares of bank stock
_____	HB 488	BERTHELOT	TAX/PROPERTY (Constitutional Amendment) Authorizes agents of the tax collector to sell property for delinquent taxes and requires the fee of the authorized agent to be included within the costs recoverable in the tax sale
_____	HB 583	MACK	ASSESSORS Requires the Livingston Parish assessor to pay the cost of certain insurance premiums for eligible retirees of the assessor's office
_____	HB 712	GREENE	TAX/SEVERANCE TAX Prohibits the state from paying interest on refunds for the overpayment of certain severance taxes
_____	HB 713	GREENE	TAX/SEVERANCE TAX Provides that severance taxes do not have to be paid during the period of a suspension or exemption from severance tax when the well operator holds a certificate of good standing

_____	HB 788	LEGER	CONVENTION FACILITIES Provides with respect to the Ernest N. Morial New Orleans Exhibition Hall Authority
_____	HB 792	REYNOLDS	ASSESSORS Authorizes the Webster Parish Assessment District to provide for an automobile expense allowance for the office of the assessor
_____	HB 1050	CHANEY	TAX/AD VALOREM-EXEMPTION Provides relative to the ad valorem tax exemption for certain agricultural machinery and other implements
_____	HB 1118	BURNS, TIM	TAX/AD VALOREM TAX Changes requirements for public hearings at which millage adjustments are considered by certain taxing authorities
_____	HB 1202	STOKES	TAX/AD VALOREM TAX Provides for procedures and requirements relative to the supplemental assessment roll for omitted or erroneously assessed properties
