_____ <b>SB 272</b>	<b>ABRAHAM</b>	<b>TAX EXEMPTIONS</b> Constitutional amendment to establish an ad valorem tax exemption for property subject to a cooperative endeavor agreement requiring the property owner to make payments in lieu of taxes. (2/3 - CA13s1(A))
_____ <b>SB 334</b>	<b>ALLAIN</b>	<b>REVENUE DEPARTMENT</b> Provides for the funding of the operations of the Department of Revenue. (2/3 - CA7s2.1(A)) (See Act)
_____ <b>SB 396</b>	<b>ABRAHAM</b>	<b>TAX/AD VALOREM</b> Authorizes and provides for cooperative endeavor agreements between local governmental subdivisions and other entities that may require payments in lieu of ad valorem taxes. (See Act)
_____ <b>SB 423</b>	<b>WHITE, B</b>	<b>SPECIAL DISTRICTS</b> Provides for the city of St. George Transition District. (gov sig)
