_____	SB 466	HEWITT	PUBLIC MEETINGS Provides for teleconferencing of public bodies under certain circumstances. (gov sig)
_____	SB 42	WHITE, B	STATE DEPARTMENT Provides that domicile of the Department of State is in East Baton Rouge Parish. (gov sig)
_____	SB 183	HARRIS, JIMMY	ELECTION DAYS Authorizes clerks of court to have law enforcement officers at polling places on election day to enforce law and authorizes law enforcement officers to enter voting location in an emergency. (gov sig)
_____	SB 75	MIZELL	VOTERS/VOTING Provides relative to addresses to where absentee by mail ballots are sent. (gov sig)
_____	SB 397	BERNARD	VOTERS/VOTING Provides relative to counting absentee and early voting ballots. (gov sig)
_____	SB 422	BERNARD	VOTERS/VOTING Provides for the reinspection of voting machines and recounting of absentee by mail and early voting ballots. (gov sig)

_____	SB 351	CATHEY	POLITICAL PARTIES Allows each recognized political party to determine the composition of its state central committee. (gov sig)
_____	SB 218	CLOUD	ELECTED OFFICIALS Requires that completion of qualifying forms for elected office shall include submission of valid identification. (8/1/20)
_____	SB 238	ALLAIN	CAMPAIGN FINANCE Provides for repayment of personal contributions or loans. (8/1/20)
_____	SB 80	CARTER, TROY	SCHOOLS Exempts interior blueprints and floor plans of public school buildings and facilities from the definition of "public records". (gov sig)
_____	SB 191	WHITE, B	PUBLIC RECORDS Provides relative to confidentiality of certain information contained in contracts with the Department of Economic Development. (gov sig)
