_____	<b>SB 50</b>	<b>ALLAIN</b>	<b>CAPITAL OUTLAY</b> Provides relative to the capital outlay process. (gov sig) (Item #15)
_____	<b>SB 52</b>	<b>REESE</b>	<b>TAX/AD VALOREM</b> Provides for credits for certain ad valorem taxes paid for the 2020 tax year. (gov sig) (Item #26)
_____	<b>SB 62</b>	<b>SMITH, G.</b>	<b>TAX/AD VALOREM</b> Provides for the refundable portion of the inventory tax credit for certain manufacturers impacted by the 2020 emergencies and disasters. (gov sig) (Item #26)
_____	<b>SB 72</b>	<b>TALBOT</b>	<b>TAX/INCOME/CORPORATE</b> Authorizes an income tax credit for certain businesses whose operations were interrupted as a result of the COVID-19 pandemic. (gov sig) (Items #26 and #65)
