

1 CHAIRMAN ZALEWSKI: Are we ready to proceed in
2 Springfield?

3 THE CLERK: Yes, we're ready.

4 CHAIRMAN ZALEWSKI: Okay. I appreciate everyone's
5 flexibility and patience during this time. And I just want to
6 remind the Staff that is calling in but not speaking to please
7 mute your phones during the meeting.

8 Under the Opening Meetings Act, and in
9 accordance with the Governor's Executive Orders, I call the
10 April 15th, 2020 Regular Open Meeting to order.

11 Before we proceed, I would like to indicate
12 that, due to the emergency measures implemented in response to
13 the COVID-19 pandemic, and the Governor's Executive Orders, we
14 expect more remote participation from the general public and
15 the Commissioners.

16 The court reporter is also calling in; and,
17 for clarity of the record, I would ask every Commissioner to
18 state their name every time they speak. Thank you. And with
19 that, we will proceed.

20 Commissioner Kimbrel is with me in Chicago.
21 Commission Carrigan is joining us from Springfield.
22 Commissioners Oliva and Bocanegra are calling in. I've already

1 checked that Commissioners Oliva and Bocanegra are on the line
2 with us. So we have a quorum.

3 We have no requests to speak, so we will start
4 with our Transportation Agenda.

5 There are edits to the March 4th and March
6 18th, 2020 Transportation Special Open Meeting Minutes. Are
7 there any objections to approving the minutes as edited?

9 CHAIRMAN ZALEWSKI: Hearing none, the minutes are
10 approved.

11 Under our Railroad Items, Item RR-1 concerns a
12 Public Safety Improvement Project at railway crossing. The
13 Order authorizes a time extension for the petitioner to acquire
14 certain property rights for the completion of the project.

15 Are there any objections to approving the
16 Order?

18 CHAIRMAN ZALEWSKI: Hearing none, the Order is approved.

19 Under our Motor Carrier items, Items MC-1 and
20 MC-2 concern applications for renewal of Commercial Relocation
21 Licenses. The Order grants renewal, finding that the
22 Applicants meet the requirements.
