6                   Item MC-2 concerns an application to  
7 transfer a Certificate of Public Convenience and

10 to provide the motor carrier services requested.

14                   CHAIRMAN SCOTT: Hearing none, the Order  
15 is approved.

16                   Item MC-3 concerns a stipulated  
17 agreement for alleged violations of the Illinois
