#### I. BACKGROUND

Pursuant to Section 8-201.10(b) of the Illinois Public Utilities Act, all public utilities are required to file with the Illinois Commerce Commission (ICC) by the 15<sup>th</sup> of each month a report on 22 credit, collection, and arrearage metrics for the immediately preceding month by zip code. The public utilities are encouraged by the ICC, but not required, to provide the data separately for residential low-income customers. For the purposes of this voluntary reporting, residential electric and gas low-income customers are those enrolled in the Low-Income Home Energy Assistance Program (LIHEAP) and their data is a subset of the reported residential customer information.

Of the 15 utilities reporting as of the date of this report, only eight utilities provide disaggregated residential low-income data: Ameren Illinois (Ameren IL), Commonwealth Edison (ComEd), Consumers Gas (Consumers), Illinois Gas (IL Gas), Northern Illinois Gas (Nicor), North Shore Gas (North Shore), Peoples Gas Light & Coke (Peoples Gas), and Prairie Path Water (PPWC). Unlike the other seven energy companies listed, PPWC's residential low-income water and sewer customers are defined as customers with incomes below the federal poverty line who opted into the utility's low-income tariff rate. This Staff Report will focus on the reported low-income data where such data is available.

The remaining seven utilities that did not separately provide residential low-income data are: Aqua Illinois (Aqua), Illinois American Water (IAWC), Liberty Utilities Midstates Natural Gas (Liberty), Mt. Carmel Public Utility (Mt. Carmel), MidAmerican Energy Company (MEC), Powers Water Company (Powers), and Silvis Heights Water Corporation (Silvis Heights).

All Section 8-201.10(b) reports are available to the public at the ICC's website at <a href="https://www.icc.illinois.gov/industry-reports/credit-collections-and-arrearages-reports">https://www.icc.illinois.gov/industry-reports/credit-collections-and-arrearages-reports/monthly-dashboard</a>. All company data can be viewed and downloaded by the public.

#### WORKSHOP AND TEMPLATE REPORT

In collaboration with stakeholders in a public workshop held in February 2022, ICC Staff developed a standard report template to be used by the utilities for its required Section 8-201.10(b) monthly reports. *Utility data filed using that standard monthly report template were used to prepare this Staff Report*. Various factors, including the need for the companies to make changes to their information technology systems, delayed the ability of some utilities to submit their data using the report template. Accordingly, the earliest data for the larger public utilities in this Staff Report are as follows: ComEd, Peoples Gas, North Shore, IAWC, and Aqua – March 2022; MEC – April 2022; Ameren IL – June 2022; and Nicor – July 2022.

#### DATA SET AND REPORT PARAMETERS

For the reasons explained above, 2022 monthly data are available for 10 months for most public utilities, while others report data for six (Nicor), seven (Ameren IL) or nine (MEC) months.

Zip code-level data for Consumers Gas is available only for the last four months of 2022. Year 2023 monthly information consists of 12 months of data for all companies including at the zip code level.

The data presented in the tables and charts in this report are the average of the monthly observations reported per year. They are either rounded to the nearest whole dollar or to the nearest tenth or hundredth percent (i.e., one or two decimal places). For this reason, some total columns may not appear to add up. The underlying raw data can be obtained from the ICC websites noted above.

Residential low-income data is a *subset* of residential data. Therefore, where applicable, this report separately identifies "**Residential Non-Low Income**" data (which is total residential customer data *minus* the corresponding data for residential low income customers) and "**Residential Low Income**" information under "Part II. High Level Overview." Some companies do not separately report residential low income data and that is noted where applicable. Under "Part III. Top 20 Zip Codes for Arrearage Metrics and Equity Investment Eligible Communities," only "**Residential**" data (which *includes* residential low income data) and "**Residential Low Income**" data are reported. While some high level tables and charts in this report provide non-residential data, they are not discussed as the focus of this report is on residential customer outcomes.

Not all collected metrics are presented in this Staff Report. For example, medical payment arrangements are not included (Metric #11 through #14) because most companies did not report having any such arrangements and those that did had very few customers with that arrangement. Further, companies that do not have data for a particular metric are excluded from the corresponding table and chart for that metric. For example, IL Gas is not shown in the gas Late Payment Fee chart and table since IL Gas does not charge late payment fees.

This Staff Report focuses on the statutorily required metrics pertaining to disconnections, late payment fees, required deposits, and arrearages, i.e., over 30 days past due accounts for customers that are or are not taking service under a deferred payment arrangement (DPA).

#### APPLICABLE STATUTE

The 22 metrics required to be measured and reported by the public utilities monthly to the ICC per 220 ILCS 5/8-201.10(b) are as follows:


- (1) the number of customers, by **customer class and type of utility service provided**, during each month;
- (2) the number of customers, by customer class and type of utility service, **receiving disconnection notices** during each month;
- (3) the number of customers, by customer class and type of utility service, **disconnected for nonpayment** during each month;
- (4) the number of customers, by customer class and type of utility service, **reconnected because** they have paid in full or set up payment arrangements during each month;
- (5) the number of **new deferred payment agreements**, by customer class and type of utility service, each month:

- (6) the number of customers, by customer class and type of utility service, **taking service** at the beginning of the month **under existing deferred payment arrangements**;
- (7) the number of customers, by customer class and type of utility service, **completing deferred** payment arrangements during the month;
- (8) the **number of payment agreements**, by customer class and type of utility service, **that failed** during each month;
- (9) the number of customers, by customer class and type of utility service, **renegotiating deferred** payment arrangements during the month;
- (10) the number of customers, by customer class and type of utility service, assessed late payment fees or charges during the month;
- (11) the number of customers, by customer class and type of utility service, **taking service** at the beginning of the month **under existing medical payment arrangements**;
- (12) the number of customers, by utility service, **completing medical payment arrangements** during the month;
- (13) the number of customers, by utility service, **enrolling in new medical payment arrangements** during the month;
- (14) the number of customers, by utility service, renegotiating medical payment arrangements plans during the month;
- (15) the number of customers, by customer class and utility service, with **required deposits** with the company at the beginning of the month;
- (16) the number of customers, by customer class and utility service, required to submit new deposits or increased deposits during the month;
- (17) the number of customers, by customer class and utility service, whose **required deposits were** reduced in part or forgone during the month;
- (18) the number of customers, by customer class and utility service, whose **deposits were returned** in full during the month;
- (19) the number of customers, by customer class and utility service, with past due amounts greater than 30 days past due at the beginning of the month and taking service at the beginning of the month under existing deferred payment arrangements;
- (20) the dollar volume of past due accounts, by customer class and utility service, for customers with past due amounts greater than 30 days past due at the beginning of the month and taking service at the beginning of the month under existing deferred payment arrangements;
- (21) the number of customers, by customer class and utility service, with past due amounts greater than 30 days past due at the beginning of the month and not taking service at the beginning of the month under existing deferred payment arrangements; and
- (22) the dollar volume of past due accounts, by customer class and utility service, for customers with past due amounts greater than 30 days past due at the beginning of the month and not taking service at the beginning of the month under existing deferred payment arrangements.

#### II. HIGH LEVEL OVERVIEW

# CUSTOMERS – CLASSES AND TYPE OF UTILITY SERVICE (METRIC #1)

Customer classes are broadly classified as either non-residential or residential. Seven utilities providing electric and/or gas distribution service voluntarily identified a subset of their residential customers that are considered low-income based on their enrollment in LIHEAP. Customer classes are presented by type of utility service: electric, gas, water, and sewer.



# **DISCONNECTION NOTICES (METRIC #2)**


An average of 14.6% or fewer **electric** <u>residential non-low income</u> customers received disconnection notices from the four electric utilities. From 2022 to 2023, increases ranged from 2.2% (Ameren IL) to 13.7% (Mt. Carmel) but declined by nearly 5% for MidAmerican Energy. For Ameren IL and ComEd <u>residential low-income</u> customers, their average disconnection notices were less than 10.1% and respectively increased by about 49% and 79% from 2022 to 2023.

An average of 12.85% or fewer **gas** <u>residential non-low income</u> customers received disconnection notices from the nine gas utilities. From 2022 to 2023, two increased by 5% (Consumers) and 36.5% (Mt. Carmel) while seven decreased, ranging from -0.7% (Ameren IL) to -27.9% (North Shore). In contrast, <u>residential low-income</u> disconnection notices averaged 10.5% or less and increases ranged from nearly 13.4% (Consumers) to 1,057% (Peoples Gas) from 2022 to 2023.







Only total **water** <u>residential</u> data is shown since low-income data was not separately reported or the one water utility that did report it (Prairie Path Water or PPWC) had very few customers on a low-income rate (0.3% or less). Less than 7.2% of total <u>residential</u> customers at the five **water** utilities received disconnection notices on average per month in 2022-2023 except for Silvis Heights which was 19.8% in 2023. Disconnection notices decreased from 2022 to 2023 for Aqua IL (-2.7%), IL American Water (-23.2%), and PPWC (-42.2%) but increased for Silvis Heights (173.2%).

Powers Water is omitted as all of its reported data points are zero. All Prairie Path Water data points reflect few customers receiving disconnection notices and small percentage values. Thus, its data is not visible in the monthly average graph below.






Only total **sewer** <u>residential</u> data is shown below since either low-income data was not separately reported or the one sewer utility that did report it (Prairie Path Water) had very few customers on a low-income rate (0.2% or less).

An average of less than 6.1% sewer <u>residential</u> customers received disconnection notices per month in 2022-2023. Disconnection notices from 2022 to 2023 decreased for Aqua IL (-4.6%), IL American Water (-10.3%), and Prairie Path Water (-32.3%).








#### DISCONNECTIONS DUE TO NON-PAYMENT (METRIC #3)

An average of 0.6% or fewer **electric** <u>residential non-low income</u> or <u>residential</u> customers were disconnected due to non-payment at the four electric utilities, three of which increased ranging from 4.3% (MidAmerican) to 17.4% (Ameren IL) while one declined by -33.4% (ComEd) from 2022 to 2023. In contrast, ComEd and Ameren IL <u>residential low-income</u> disconnections were 2.07% or less and respectively increased by nearly 20% and 47.6% from 2022 to 2023.



An average of 0.80% or fewer **gas** residential non-low income or total residential customers were disconnected due to non-payment of utility bills at the nine gas utilities, four of which had increases ranging from 2.7% (Nicor) to 264% (Consumers) and five with decreases ranging from - 3.6% (Peoples Gas) to -43% (IL Gas) from 2022 to 2023. In contrast, residential low-income customer disconnections were 2.08% or less and increases for four utilities ranged from 41.1% (Ameren IL) to over 4,157% (North Shore) while one declined by -94.8% (IL Gas) from 2022 to 2023.






An average of 7.2% or fewer water <u>residential</u> customers were disconnected due to non-payment of utility bills at the five water utilities in 2022-2023. Disconnection decreases ranged from -2.5% (IL American Water) to -100% (Silvis Heights) from 2022 to 2023. As noted earlier, only <u>total residential</u> data is available. Powers Water is omitted as all of its reported data points are zero.






An average of 0.74% or fewer <u>residential</u> customers were disconnected due to non-payment of utility bills at the three sewer utilities in 2022-2023. Disconnections from 2022 to 2023 declined by -20.8% (Prairie Path Water) and -24.8% (IL American Water) in 2023 but increased for Aqua IL by 10.7%.

Only total **sewer** <u>residential</u> data is shown since either residential low-income data was not separately reported or the one sewer utility that did report it (Prairie Path Water) had no low-income customers disconnected due to non-payment. Powers Water is omitted as all of its reported data points are zero.


#### LATE PAYMENT FEES (METRIC #10)

Section 8-201.8 of the Public Utilities Act prohibits late fees from being assessed on residential low income electric and gas customers beginning on January 1, 2023. The electric and gas companies explain that the non-zero values for late fees seen in the following charts in 2023 are due to timing. Non-low income customers assessed with applicable late charges in a given month are sometimes re-classified as a low income customer in the same period. In such cases, the customer is reported as a residential low income customer for that month under Metric #10.

#### **ELECTRIC UTILITIES**

An average of less than 17.6% **electric** <u>residential non-low income</u> or <u>residential</u> customers were assessed a late payment fee in 2022-2023. This average respectively increased from 2022 to 2023 by 3.32% and 10.9% at Ameren IL and Mt. Carmel, and respectively decreased by -1.7% and -10.4% at ComEd and MidAmerican Energy.

In contrast, an average of less than 7.4% <u>residential low income</u> customers were assessed a late payment fee in 2022-2023 by Ameren IL and ComEd, and respectively increased by 12.5% and 50.1% from 2022 to 2023.




#### **GAS UTILITIES**

An average of 30.8% or fewer **gas** <u>residential</u> customers were assessed a late payment fee in 2022-2023. Increases ranged from 4.1% (Ameren IL) to 69.6% (Nicor) at three utilities and decreases ranged from -2.09% (North Shore) to -26.4% (Liberty) at five utilities from 2022 to 2023.


In contrast, an average of 2.6% or fewer gas <u>residential low income</u> customers were assessed a late payment fee over the same period. From 2022 to 2023, it increased by 24.6% for Ameren IL but decreases ranged from -2.09% (North Shore) to -100% (Nicor) for the remaining four utilities that disaggregated their low-income customer data.


Illinois Gas does not assess late fees and is, thus, excluded from the chart below.



# **WATER UTILITIES**

An average of less than 49% **water** <u>residential</u> customers were assessed late payment fees by four water utilities from 2022-2023, declining by up to 22.7% (Aqua IL) and increasing by 195.2% for Silvis Heights in 2023.






IAWC indicates that it typically waives late payment charges in January, resulting in a large one-time reduction in assessed water late payment fees in a calendar year.

#### **SEWER UTILITIES**

Up to 57.8% sewer residential accounts were assessed late payment fees by three sewer utilities from 2022-2023, with decreases ranging from -14.8% (IAWC) to -18.4% (Aqua IL) in 2023.





IAWC indicates that it typically waives late payment charges in January, resulting in a large one-time reduction in assessed sewer late payment fees in a calendar year.


# **DEPOSITS REQUIRED (METRIC #15)**

Section 8-201.7 of the Public Utilities Act prohibits requiring utility deposits as security for non-payment from <u>residential low income</u> electric and gas customers upon the statute's enactment (i.e., September 16, 2021). The statute exempts from this requirement instances where the utility can prove that the low income customer engaged in utility equipment tampering in the prior five years.

The non-zero electric and gas data points seen in the charts in this section are explained by the utilities as a timing issue. A non-low income customer required to make a deposit at the beginning of a month and re-classified in the same month as a low income customer would be reflected as a residential low-income customer in Metric #15. Upon notification of a customer's low income status, the deposit is refunded and reported the next month under Metric #18 (Deposits Returned in Full) for residential low income customers.







The monthly average of electric <u>residential non-low income</u> customer accounts more than 30 days past due under a deferred payment arrangement (DPA, Metric #19) in 2022 to 2023 ranged from 19 or 0.44% of this class of customers (Mt. Carmel) to 81,592 customers or 2.3% (ComEd). The monthly average arrearage amount (Metric #20) ranged from \$191 (Mt. Carmel) to \$529 (Ameren IL) per customer. In contrast, Metric #19 for <u>residential low income</u> customers ranged from 6,779 or 3.7% of this class of customers (ComEd) to 17,295 or 21.3% (Ameren IL). The monthly average arrearage amount (Metric #20) ranged from \$362 (ComEd) to \$548 (Ameren IL) per customer.



The monthly average of gas <u>residential non-low income</u> customer accounts more than 30 days past due under a DPA (Metric #19) in 2022 to 2023 ranged from three or 0.07% of this class of customers (Consumers) to 61,573 or 3.1% (North Shore). The monthly average arrearage amount (Metric #20) ranged from \$27 or (Mt. Carmel) to \$692 (Peoples Gas). In contrast, Metric #19 for <u>residential low-income</u> customers ranged from 0.10 or 0.03% of this class of customers (Consumers) to 11,567 or 21.7% (Ameren IL). The monthly average arrearage amount (Metric #20) ranged from \$126 (Consumers) to \$569 (Peoples Gas) per customer. Illinois Gas reported no data for Metrics #19 and #20.



The monthly average of water <u>residential and residential non-low income</u> customer accounts more than 30 days past due under a DPA (Metric #19) in 2022 to 2023 ranged from two or 0.4% (Silvis Heights) of this class of customers to 6,400 or 2.84% (IL American Water). The monthly average arrearage amount (Metric #20) ranged from \$129 (Silvis Heights) to \$401 (Aqua IL). Only Prairie Path Water disaggregated residential low income data. Its Metric #19 for water <u>residential low income</u> customers averaged one or 3% of total low-income customers with a monthly average arrearage amount (Metric #20) of \$100, a 23.3% reduction from 2022.


#### **SEWER UTILITIES**

The monthly average of sewer <u>residential non-low income</u> customer accounts more than 30 days past due under a DPA (Metric #19) in 2022 to 2023 ranged from 28 or 0.83% of this class of customers (Prairie Path Water) to 2,103 or 2.2% (IL American Water). The monthly average arrearage amount (Metric #20) ranged from \$138 (Silvis Heights) to \$578 (Aqua IL). Only Prairie Path Water disaggregated residential low income data. Its Metric #19 for sewer <u>residential low income</u> customers averaged one or 20.6% of total low income customers. The monthly average arrearage amount (Metric #20) was \$138 in 2023, a 10% reduction from 2022.



The monthly average electric <u>residential non-low income</u> customer accounts with bills more than 30 days past due with <u>no</u> deferred payment arrangement (DPA, Metric #21) in 2022 to 2023 ranged from 109 or 2.5% of this class of customers (Mt. Carmel) to 251,588 customers or 7.1% (ComEd). The monthly average arrearage amount (Metric #22) ranged from \$128 (Mt. Carmel) to \$329 (Ameren IL) per customer. In contrast, Metric #21 for electric <u>residential low income</u> customers ranged from 19,686 or 24.2% of this class of customers (Ameren IL) to 40,335 or 21.6% (ComEd). The monthly average arrearage amount (Metric #22) ranged from \$304 (Ameren IL) to \$406 (Ameren IL) per customer.



The average number of gas <u>residential non-low income</u> customers with bills more than 30 days past due with <u>no</u> DPA (Metric #21) in 2022 to 2023 ranged from 60 or 1.8% of this class of customers (Mt. Carmel) to 156,017 or 7.8% (Nicor). The monthly average arrearage amount ranged from \$33 (Liberty) to \$746 (Peoples Gas). In contrast, Metric #21 for gas <u>residential low income</u> customers ranged from two or 0.6% of this class of customers (Consumers) to 15,034 or 23.4% (Peoples Gas). The monthly average arrearage amount (Metric #22) ranged from \$99 (Consumers) to \$576 (Peoples Gas) per residential low income customer.



The average number of water <u>residential</u> customers with bills more than 30 days past due with <u>no</u> DPA (Metric #21) in 2022 to 2023 ranged from 49 or 10.9% of this class of customers (Silvis Heights) to 12,493 or 21% (Aqua IL). The monthly average arrearage amount (Metric #22) ranged from \$51 (Silvis Heights) to \$520 (IL American Water). In contrast, Metric #21 for water <u>residential low income</u> customers from Prairie Path Water ranged from less than one in 2022 to three (or 10% of total low-income customers) in 2023 with a monthly average arrearage amount (Metric #22) of \$33 in 2022 and \$105 in 2023 per residential low income customer.


The average number of sewer residential non-low income customers with bills more than 30 days past due with no DPA (Metric #21) in 2022 and 2023 ranged from 24 or 0.03% of this class of customers (IL American Water) to 4,127 or 13.6% (Aqua IL). The monthly average arrearage amount ranged from \$143 (Prairie Path Water) to \$826 (IL American Water). In contrast, Metric #21 for Prairie Path Water's sewer residential low income customers ranged from one to four in only some months, resulting in a monthly average for Metric #21 of less than one customer. The monthly average arrearage amount for Prairie Path Water's residential low-income customers was \$176 in 2022 per customer and declined to \$119 in 2023.

# III. TOP 20 ZIP CODES FOR ARREARAGE METRICS & EQUITY INVESTMENT ELIGIBLE COMMUNITIES

The relevant statute requires data on 22 credit, collection, and arrearage metrics to be reported by zip code. This section highlights the four metrics related to arrearages (Metrics #19 - #22) and the top 20 zip codes with the highest results for the larger electric, gas, water, and sewer public utilities. As some zip codes on average have very few customer accounts per year, the top 20 zip codes were selected from those with more than 100 residential customer accounts. Unlike in the previous section, the <u>residential</u> zip code data reported in the following tables *include* data for <u>residential low-income</u> customers. Despite the overlap, it is noteworthy that for certain companies, many of the top 20 residential zip codes do not correspond to the top 20 zip codes for residential low income customer accounts.

The average of each of the four metrics were calculated per company, per customer class, per zip code, and per month. The resulting monthly averages were then averaged per year for each zip code, and the top 20 results (where applicable) are shown in the tables in this section.

A zip code may cover several municipalities. For the purposes of this report, only the one municipality recommended by the U.S. Postal Service website is cited.

The Illinois Power Agency (IPA) publishes an <u>Equity Investment Eligible Community Map</u> (EIEC map at <a href="https://energyequity.illinois.gov/resources/equity-investment-eligible-community-map.html">https://energyequity.illinois.gov/resources/equity-investment-eligible-community-map.html</a>) that identifies "R3 areas" and environmental justice communities (*see* 20 ILCS 3855/1-10). A top 20 zip code within an EIEC is noted with a green check mark ( \( \sqrt{} \)).

#### ACCOUNTS & DOLLAR VOLUMES > 30 DAYS PAST DUE UNDER A DPA (METRIC #19 - #20)

The raw data for Metric #19 (Number of Accounts Over 30 Days Past Due Under a DPA) per zip code per month for *all residential* customers was divided by the corresponding average number of *total residential* customers for the same zip code and month. The resulting monthly averages were averaged per calendar year to determine the *average percentage of residential customer accounts with an arrearage balance over 30 days past due under a DPA* per year. The same calculations were made on the subset of *residential low-income customers*.

The raw data for Metric #20 (Dollar Volume of Accounts Over 30 Days Past Due Under a DPA) per zip code per month for *all residential* customers was divided by the corresponding average number of *total residential* customers for the same zip code and month. The resulting monthly averages were averaged per calendar year to determine the *average arrearage balance per residential customer account over 30 days past due under a DPA* per year. The same calculations were made on the subset of *residential low-income customers*.

#### ELECTRIC - AMEREN IL AND COMED

Ameren IL's electric data consist of 7 months in 2022 and 12 months in 2023 for 888 zip codes. Table 6.1 below shows the top 20 Ameren IL electric <u>residential</u> zip codes with the **highest percentage of average customer accounts that are past due over 30 days under a DPA** (Metric #19) in **2022** ranged from a high of 21.2% (62206 – East St. Louis) to a low of 10.8% (62856 – Logan). The average number of electric residential customers per zip code in the top 20 zip codes in 2022 was 2,341. In **2023**, Metric #19 ranged from a high of 22.1% (62206 – East St. Louis) to a low of 13.7% (62018 – Cottage Hills). The average number of electric residential customers per zip code in the top 20 zip codes in 2023 was 1,360.

For the subset of <u>residential low-income</u> customers, the top 20 Ameren IL electric zip codes with the **highest percentage of average customer accounts that are past due over 30 days under a DPA** (Metric #19) in **2022** ranged from a high of 32.3% (61606 – Peoria) to a low of 19.9% (62526 – Decatur). The average number of electric residential low-income customers in the top 20 zip codes in 2022 was 648. In **2023**, Metric #19 ranged from a high of 40.1% (62206 – East St. Louis) to a low of 27.6% (61615 – Peoria). The average number of electric residential low-income customers per zip code in the top 20 zip codes in 2023 was 463.





ComEd's electric data consist of 10 months in 2022 and 12 months in 2023 for 567 zip codes. Table 6.3 below shows the top 20 ComEd <u>residential</u> zip codes with the **highest percentage of average customer accounts that are past due over 30 days under a DPA** (Metric #19) in **2022** ranged from a high of 6.1% (60944 – Hopkins Park) to a low of 3.4% (60155 – Broadview). The average number of residential customers per zip code in the top 20 zip codes in 2022 was 9,636. In **2023**, Metric #19 ranged from 10.9% (60484 – University Park) to 7.1% (60466 – Park Forest). The average number of residential customers per zip code in the top 20 zip codes in 2023 was 9,617.

For the subset of <u>residential low-income</u> customers, the top 20 ComEd zip codes with the **highest percentage of average customer accounts that are past due over 30 days under a DPA** (Metric #19) in **2022** ranged from a high of 7.5% (60473 – S. Holland) to a low of 5.9% (60548 – Sandwich). The average number of residential low-income customers in the top 20 zip codes in 2022 was 623. 



































A visual representation of the nine zip codes in 2023 for Metric #21 for PPWC sewer residential customers listed in Table 11.11 above are shown in the map below.





Table 11.12 below shows the eight PPWC sewer <u>residential</u> zip codes with **customer** accounts that are past due over 30 days with no DPA (Metric #22) in 2022 on average ranged from \$234 (61525 – Dunlap) to \$76 (60404 – Shorewood).<sup>8</sup> In 2023, Metric #22 ranged from a high of \$252 (61525 – Dunlap) to a low of \$76 (61032 – Freeport). The average number of sewer residential customer accounts per zip code in the top zip codes in 2022 and 2023 were respectively 425 and 426.
