1 CHAIRWOMAN ZALEWSKI: Good morning, are we
2 ready to proceed in Springfield?

3 CLERK: Yes we are, Madam Chair.

4 CHAIRWOMAN ZALEWSKI: Thank you. Then under
5 the Open Meetings Act, I call the September 30th, 2021,
6 Regular Open Meeting to order.

7 Commissioners Bocanegra, Carrigan,
8 and Kimbrel are with me in Chicago. We have a
9 quorum.

11 So we're moving on to our
12 Transportation Agenda. There are edits to the
13 September 2nd Transportation Regular Open Meeting

21 RR-1 and RR-2 concern public safety improvement
