1 JUDGE KIRKLAND-MONTAQUE: By the power vested
2 in me by the State of Illinois and the Illinois
3 Commerce Commission, I now call for status hearing
4 Docket No. 74 RTV-R Sub 15 for hearing. This is a
5 hearing on the fitness to hold a commercial vehicle
6 relocater's license.

7 May I have appearances, please. Let's
8 start with Staff.

9 MR. BARR: Good morning, your Honor -- or good
10 afternoon, your Honor.

11 My name is Benjamin Barr, I appear on
12 behalf of the staff of the Illinois Commerce
13 Commission. My office is located at 160 North
14 LaSalle Street, Suite 800, Chicago, Illinois 60601,
15 and my phone number is (312) 814-2859.

16 JUDGE KIRKLAND-MONTAQUE: Okay. Rendered?

17 MR. ROTHCHILD: Good afternoon, your Honor. My
18 name is Donald S. Rothchild. My business address is
19 835 McClintock Drive, Burr Ridge, Illinois 60527.
20 I'm an attorney licensed by the Supreme Court, and I
21 represent the respondent, Rendered Services, Inc.

22 MR. DOUGHERTY: Good afternoon, your Honor,

1 Brian Dougherty, same office information as Donald
2 Rothchild. I'm also licensed by the Illinois
3 Supreme, and I appear for Rendered Services, Inc.

4 JUDGE KIRKLAND-MONTAQUE: Okay. The last time
5 we met I think we needed time to respond to the
6 motion to compel, and then you needed time to reply
7 to the response.

8 MR. ROTHCHILD: Well, I think actually what
9 happened was that the Staff Transportation Counsel
10 was given time to gather additional information in
11 response to our previously filed discovery requests,
12 and had a due date of November 29, and Mr. Barr was
13 timely and furnished to us quite a bit of material.
14 In response to adding to the discovery, we diligently
15 went through it and determined that there are several
16 deficiencies that we had not discussed, which are the
17 subject of a 201(k) letter and hopefully a 201(k)
18 conference that we will have in the near future.

19 And then there are several issues that
20 we had gone around with Ms. Anderson and Mr. Barr,
21 and were unable to resolve even with the supplemental
22 responses of Staff concerning which we have prepared

1 and tender today, because I believe today was the due
2 date and not the response date for the motion to
3 compel.

4 JUDGE KIRKLAND-MONTAQUE: Okay.

5 MR. ROTHCHILD: So I am sending this to
6 Springfield. Here's a copy of the cover letter.
7 Here's a copy of the cover letter, Mr. Barr. And the
8 original and two copies are being filed in
9 Springfield, and I have a courtesy copy for your
10 Honor and one for Mr. Barr. And we ask that a
11 briefing schedule be set for this motion to compel.
12 It's not as long as it's looks, it's seven pages. It
13 just has some attachments.

14 JUDGE KIRKLAND-MONTAQUE: Okay. Do you want to
15 time reply to this before we set a briefing schedule?

16 MR. BARR: Yes, your Honor.

17 Typically, we would just ask for the
18 14 days, but I am going to be out starting the 26th
19 for the holidays and just would ask that that be
20 taken into consideration and set it for sometime in
21 2017 for Staff's reply or response.

22 MR. ROTHCHILD: We would have no objection.

1 JUDGE KIRKLAND-MONTAQUE: To that?

2 MR. ROTHCHILD: I'm going away too.

3 JUDGE KIRKLAND-MONTAQUE: Which one of you
4 would take me with you?

5 MR. BARR: Anywhere?

6 MR. ROTHCHILD: I'm surprised he's accumulated
7 days of already. He just got here.

8 JUDGE KIRKLAND-MONTAQUE: He's been here for
9 actually longer than you would think.

10 MR. ROTHCHILD: Okay.

11 JUDGE KIRKLAND-MONTAQUE: Since at least May.

12 MR. ROTHCHILD: Okay. Time flies, right? It
13 feels longer.

14 JUDGE KIRKLAND-MONTAQUE: We're having fun.

15 MR. ROTHCHILD: Yeah.

16 JUDGE KIRKLAND-MONTAQUE: And then yet another
17 reminder to update my calendar.

18 MR. ROTHCHILD: Yeah, I have the same problem.
19 I'm here with my --

20 JUDGE KIRKLAND-MONTAQUE: We'll go off the
21 record.

1 (A discussion was held off
2 the record.)

3 JUDGE KIRKLAND-MONTAQUE: Let's go back on the
4 record.

5 All right. As the parties are
6 continuing to try to resolve discovery matters, and
7 this matter will be continued -- I'm sorry. Let me
8 first say that Staff will reply to -- respond,
9 rather, to the motion to compel that was filed
10 instanter, and will be filed with the Springfield
11 office today.

12 Staff has until January 9th to respond
13 to Rendered's motion to compel, and Rendered shall
14 have until January 24th to file the reply to Staff's
15 filing. And then we shall have a status hearing on
16 these matters on Wednesday, February 1st at 1:30 p.m.
17 here in Chicago.

18 MR. ROTHCHILD: Very well.

19 JUDGE KIRKLAND-MONTAQUE: Is there anything
20 else we need to discuss?

21 MR. ROTHCHILD: I have several items to discuss
22 with Mr. Barr if we can use your facilities here.
