- 1 CHAIRMAN BOX: Is everything ready in
- 2 Springfield?
- JUDGE ALBERS: It is, Mr, Chairman.
- 4 CHAIRMAN BOX: Pursuant to the provisions of
- 5 the Illinois Open Meetings Act, I now convene a
- 6 special open meeting of the Illinois Commerce
- 7 Commission. With me in Chicago are Commissioners
- 8 Ford, O'Connell-Diaz, Elliott and Colgan.
- 9 We have a forum.
- Before moving into the agenda, this is
- 11 the time we allow members of the public to address
- 12 the Commission. Member of the public wishing to
- 13 address the Commission must notify the Chief Clerk's
- 14 Office at least 24 hours prior to the bench session.
- 15 According to the Chief Clerk's Office, there are nine
- 16 requests to speak. Please forgive me if I don't do
- 17 justice to some of these names.
- The first is Mr. David Schweickart,
- 19 you have 3 minutes to speak.
- 20 MR. DAVID SCHWEICKART: Where do I sit?
- 21 CHAIRMAN BOX: Up here at the microphone. Make
- 22 sure the green light is on and you have 3 minutes.

- 1 MR. DAVID SCHWEICKART: Well, I'm David
- 2 Schweickart. I'm a professor of law at Loyola
- 3 University. I teach a course in ethics and economic
- 4 justice, which is what brings me here. Let me thank
- 5 you for the opportunity to speak, if only for 3
- 6 minutes; but I must express my dismay at the lack of
- 7 information on the Web site about this very important
- 8 issue.
- 9 Last night in preparation for my 3
- 10 minutes of glory, I went to the natural gas section
- of your Web site. I clicked on gas policy meetings,
- 12 the latest notification was for March 2008. I
- 13 clicked on the annual report on the development of
- 14 natural gas markets in Illinois, the latest available
- 15 report was 2007. I clicked on reports filed by the
- 16 Federal Energy Regulatory Commission, no reports were
- 17 posted, zero. Finally I clicked on rate case history
- 18 and got a long Excel spreadsheet for water and sewer
- 19 rates dating from 1975 on the natural gas Web page.
- 20 As a taxpayer and concerned citizen, I
- 21 find this lack of readily-accessible information
- deeply disturbing. This, after all, is a decision

- 1 that will affect millions of people especially our
- 2 most vulnerable citizens. Equally disturbing is that
- 3 Peoples Gas claims the rate hike is needed to pay for
- 4 replacing aging infrastructure, this strikes me as
- 5 bogus. Before paying out dividends to shareholders,
- 6 companies are expected to set aside depreciation
- 7 allowances, are they not? There's nothing mysterious
- 8 or unforeseeable about equipment wearing out. Why
- 9 are these set-asides inadequate? Integrys Energy
- 10 Group has been paying substantial dividends annually
- 11 so there is no shortage of funds. This sounds to me
- 12 like a scam.
- Finally, it's surely obvious in these
- 14 times when unemployment is rising, hours of work are
- being cut back, raises for ordinary workers are
- virtually nonexistent, it's more than unseemly to
- 17 raise the cost of so basic an item as home heating.
- 18 Surely justice demands that the pain be shared, which
- 19 means, as I see it, shareholders should do without
- 20 dividends when the economy is in such a slump. To
- 21 grant a rate hike now would not only be astonishingly
- 22 insensitive, but fundamentally unjust, a clear case

- 1 of dereliction of duty.
- 2 Bankers get their bonuses even when
- 3 they screw up massively inflicting the damage on
- 4 millions, taxpayers foot the bill. Peoples Gas wants
- 5 more money, ordinary citizens foot the bill, and
- 6 those who can't get their utilities disconnected. I
- 7 realize that you have no control over those bankers,
- 8 but you do have the power to not only block this rate
- 9 hike, but I think you have the power to halt the
- 10 disconnections. I urge you to do the things within
- 11 your power, halt and block.
- 12 Thank you for your attention. Please
- 13 do the right thing.
- 14 CHAIRMAN BOX: Thank you very much.
- Next we have Ms. Elaine Phillips.
- Ms. Phillips, you have 3 minutes.
- 17 MS. ELAINE PHILLIPS: Good morning. My name is
- 18 Elaine Phillips and I have lived in Chicago all my
- 19 life. I am a butcher and a stock person in a grocery
- 20 store. I'm speaking to you today on behalf of myself
- 21 and my family. Right now I have no gas and I have
- 22 done everything Peoples Gas has asked me to. I'm

- 1 paying Peoples Gas for property damage which I had
- 2 nothing to do with. I have made a good faith payment
- 3 that they asked for, but Peoples Gas still did not
- 4 reconnect my gas. Now they want to raise the rates
- 5 again? What do we have to give up? An arm and a
- 6 leg, now we the people of Illinois, need you, the ICC
- 7 to do your job. Reject the rate increase. Turn my
- 8 gas -- no, everyone's gas back on. Roll back the
- 9 rates and make gas affordable for everyone.
- 10 Thank you.
- 11 CHAIRMAN BOX: Thank you.
- 12 Next we have Ms. Ruth Bell Mejias.
- Ms. Mejias, you have 3 minutes.
- 14 MS. RUTH BELL MEJIAS: Yes.
- 15 COMMISSIONER BOX: Just speak directly into the
- 16 microphone because this is being carried over the
- 17 Internet and the Springfield office.
- MS. RUTH BELL MEJIAS: Good morning and thank
- 19 you for the opportunity to speak. My name is Ruth
- 20 Bell Mejias. I am a social worker here in the City
- 21 and I stand here -- or sit here today to tell you
- 22 just one thing, reject any rate hike from Peoples

- 1 Gas.
- Peoples Gas is a profitable, private
- 3 business. They're accountable to their shareholders,
- 4 but the Illinois Commerce Commission is a Government
- 5 agency and you're accountable by law to the Illinois
- 6 residents. You pledged to keep the utilities
- 7 available, but the 56,000 families that started last
- 8 year without heat would tell you that they are not,
- 9 in fact, available. You pledged to keep the
- 10 utilities affordable, but the 80,000 families that
- 11 received disconnect notices last April would argue
- 12 that it is not, in fact, affordable. Your actions
- 13 have made heat a luxury.
- 14 Through abandoning your
- 15 responsibilities, you've made it possible for Peoples
- 16 Gas to a pay out huge dividends to their stockholders
- 17 while people resort to space heaters and other unsafe
- 18 methods to heat their homes. Additionally, each year
- 19 there are apartment and house fires where men, women,
- 20 and children die. Peoples Gas puts forth that the
- 21 rate increase will average out to about \$12 a month,
- trying to minimize the effect it will have on the

- 1 current economic community. \$161 million, \$75
- 2 million or even \$10 million will devastate the local
- 3 economy. That's millions of dollars that will be
- 4 stripped from people's wallets, millions of dollars
- 5 that they're not going to spend at the local grocery
- 6 store, bookstore, concerts, florists and other
- 7 businesses. Chicago lost over 200,000 jobs last
- 8 year, it can't afford to lose millions more in
- 9 disposable income.
- 10 As a social worker, I have seen
- 11 firsthand how low-income families struggle to pay
- 12 rent, utilities and medical costs. I see how they
- 13 flounder in the winter literally picking up cans out
- of the trash to help pay the gas bill. We don't know
- 15 how many families this year will start the winter
- 16 without heat; but with a rate hike another chunk,
- 17 that chunk that's barely holding on sacrificing food,
- 18 medical expenses and safety to keep their heat on so
- 19 they don't fall through the cracks and they don't
- 20 start next year as a potential household without heat
- 21 with the number of children who die in house fires.
- 22 All this because we put profits before people.

- 1 CEDA provides limited help to some
- 2 families, but not all families. Those who are not
- documented, for example, are not eligible for CEDA;
- 4 but they, too, pay gas bills. CEDA is funded by tax
- 5 dollars, my tax dollars, your tax dollars, all of our
- 6 tax dollars. Tax dollars that end up going to
- 7 private not-for-profit business. If gas bills were
- 8 lower we wouldn't need to put so much money into
- 9 CEDA, and we can put that money into publicly funded
- 10 institutions like hospitals, public schools,
- 11 libraries. In Chicago heat is a necessity to live,
- 12 not a luxury. Reject this rate hike and any rate
- 13 hike until you can ensure that all Illinois residents
- 14 have gas service.
- 15 CHAIRMAN BOX: Thank you.
- 16 Next we'll hear from Ms. Jacqui
- 17 Abrams.
- 18 (No response.)
- 19 Next we have Ms. Dolores Smith.
- 20 MS. DELORES SMITH: Good morning. My name is
- 21 Dolores Smith and I am here today to speak on behalf
- of the Cook County Workers Benefit Council, a

- delegate body that represents the needs of services,
- 2 workers and other low-paid workers in Cook County.
- 3 We demand that the ICC do your duty
- 4 and deny any rate increase to Peoples Gas. This is
- 5 simply a matter of fulfilling your responsibilities
- 6 to the people of Illinois. The Illinois General
- 7 Assembly and Public Utilities Act of 2001 states that
- 8 the ICC is a state agency to regulate utilities and
- 9 that -- and I quote, The goals and objectives of such
- 10 regulation shall be to ensure the rates for utility
- 11 services are affordable and therefore preserve the
- 12 availability of such services to all citizens.
- 13 Heating gas is not affordable and
- 14 available to all in our city right now. Over 56,000
- 15 households in Chicago began last winter without heat.
- 16 This past April Peoples Gas sent out disconnection
- 17 notices to over 80,000 families, that's nearly 1 out
- of 10 customers. Sky high gas rates hit low-income
- 19 working families the hardest. We are forced to
- 20 choose between food and heat, short our landlords on
- 21 rent and cut back on medications. We suffer through
- 22 subfreezing temperatures and get sick or turn to

- 1 other means of staying warm. There have been fires
- 2 almost daily this winter in poor areas of Chicago as
- 3 low-income families resort to using electric space
- 4 heaters because they cannot afford their gas bill.
- 5 I'm sure you remember the three children who died in
- 6 the house fire in December 2008 after Peoples Gas
- 7 shut off their heating gas.
- 8 Each rate hike means we have less
- 9 money to spend in our communities and local
- 10 businesses have fewer customers. The Chicago economy
- 11 can ill afford another \$161 million taken out of
- 12 workers' pockets. This rate increase request is
- 13 clearly a profit grab. The parent company of Peoples
- 14 Gas, Integrys, increased profit 61.3 percent in 2008
- 15 after you, the ICC, granted Peoples a \$71 million
- 16 rate hike. And I quote from Crain's Chicago
- 17 Business, Integrys, currently has the highest
- 18 dividend yield in the utility industry, but that rich
- 19 payout is vulnerable unless Peoples can persuade
- 20 state utility regulators to give a hefty rate hike in
- 21 January.
- 22 For you, the ICC, to grant this rate

- 1 increase would be a clear dereliction of duty. We
- 2 call on you to fulfill your mandate to ensure utility
- 3 service is available and affordable and available to
- 4 all. Deny Peoples Gas a rate increase. Suspend
- 5 disconnections and reconnect service for all. ICC,
- 6 do your duty. Freeze the rates, not the rate payers,
- 7 and reject any rate increase for Peoples Gas. And I
- 8 also have some letters that were collected by other
- 9 people who feel the same way.
- 10 CHAIRMAN BOX: Thank you.
- 11 Next will be Sheila West.
- MS. SHEILA WEST: Good morning, everyone. My
- 13 name is Sheila West and I'm here to oppose the
- 14 proposed rate increase for Peoples Gas. It's not a
- 15 good idea because the economy is in a recession.
- 16 Many people, myself included, cannot afford it. We
- 17 need lower rates and not higher rates. I live with
- 18 my brother and he is the only one working. Our rent
- 19 is going up, and I am struggling to find work.
- 20 I know many families receive temporary
- 21 assistance like CEDA, but it's just that, temporary.
- 22 There's no kind of long-term solution. The ICC has

- 1 the power to put in more long-term solutions instead
- of letting Peoples Gas take more money out of our
- 3 empty pockets to line their pockets with growing
- 4 profits for shareholders and executives of Peoples
- 5 Gas. Please tell them no. Peoples Gas has taken
- 6 hundreds and millions of more dollars out of our
- 7 community. Simply put, the State of Illinois and our
- 8 city, Chicago, have probably never seen a worse
- 9 economic hardship. There have been reported deaths
- 10 and some unreported in the paper and from stories
- 11 I've heard from space heater use. You can prevent
- 12 those deaths. ICC Commissioners, please deny the
- 13 rate increase for Peoples Gas and take away the means
- 14 to approach the utilities so that we can afford.
- One more thing, it's getting
- 16 progressively expensive to live in Illinois. My
- 17 brother David had to move out to Iowa to find work.
- 18 My cousin lives in Minnesota. We can't afford it.
- 19 We have no money. Please. Peoples Gas, we cannot
- 20 afford it. I'm sorry.
- 21 Good-bye.
- 22 CHAIRMAN BOX: Next we have Ms. Doschia

- 1 Hawkins-Parker.
- 2 MS. DOSCHIA HAWKINS-PARKER: Good morning. My
- 3 name is Doschia Hawkins-Parker. I am a resident in
- 4 Chicago. I'm here to speak on behalf of the
- 5 residents in Chicago who have medical needs. I have
- 6 been a personal assistant with the Department of
- 7 Rehabilitation of Illinois. I've experienced persons
- 8 with disabilities such as burn victims, persons with
- 9 sight problems, stroke victims who have had problems
- 10 with their gas being turned off.
- 11 All low-income and fixed-income
- 12 persons do not live in fixed low-income housing.
- 13 People still are on a waiting list. Persons with
- 14 medical problems are to have priority with their
- 15 heating and cooking needs. People like these are
- 16 paying on their bills; although they are not paying
- 17 off their bills, they are paying what they can on the
- 18 bills and they are living on fixed incomes and they
- 19 are still being denied service.
- 20 In the past when Peoples Gas has been
- 21 granted higher rates, there have been fires in
- 22 apartments where there has been space heater use and

- 1 gas shutoffs, people have died in the cold. Peoples
- 2 Gas shareholders and executives seem to be the only
- 3 one benefiting from the rate increases. No new
- 4 services are being provided to the public.
- 5 Commissioners do not make our suffering worse for
- 6 their gains. Reject the Peoples Gas rates, please.
- 7 Thank you.
- 8 COMMISSIONER BOX: Next we'll hear from
- 9 Ms. Bambi Solzman.
- 10 MS. BAMBI SOLZMAN: Good morning,
- 11 Commissioners. While I'm here today with my husband,
- 12 I speak for many of my neighbors and fellow retirees.
- 13 I'm sure my feelings of outrage on the ICC's
- 14 consideration of the rate increase for Peoples Gas is
- shared by many others in this room.
- 16 My name is Bambi Solzman and I have
- 17 been a Chicago Hyde Park resident for over 40 years.
- 18 I'm a retired respiratory therapist from La Rabida
- 19 Hospital in South Shore. My husband is retired as
- 20 well and our retirement benefits are only 80 percent
- 21 of our working incomes. Meanwhile the cost of living
- 22 is skyrocketing and you plan yet another rate

- 1 increase to Peoples Gas? That would be a real burden
- 2 to us.
- 3 As a professional respiratory
- 4 therapist, I know that heat and hot water are
- 5 essential for asthmatic children and adults and
- 6 without it your life is severely threatened. To be
- 7 cut off gas service means you have a cold home and no
- 8 hot water or cooking gas, yet the ICC does nothing to
- 9 guarantee the citizens, including asthmatics, are
- 10 protected from shutoffs. Peoples Gas will delay
- 11 service disconnect for one month if you have a
- 12 medical condition where a medical professional
- 13 determines that you need heat or hot water. After
- 14 one month you can have your service disconnected and
- 15 face a life-or-death situation. I can ensure you
- 16 that asthma does not go away after one month.
- 17 Fulfill your responsibilities to the
- 18 citizens of our state. Deny any rate increase for
- 19 Peoples Gas and put a moratorium on all future
- 20 shutoffs to protect the health and well-being of our
- 21 residents.
- 22 Thank you.

- 1 CHAIRMAN BOX: Thank you.
- Next we'll hear from Marissa Brookes.
- 3 MS. MARISSA BROOKES: Good morning. My name is
- 4 Marissa Brookes. I am a Rogers Park resident and
- 5 therefore a customer of Peoples Gas. I'm also a
- 6 graduate student at Northwestern University. I'm
- 7 here to voice my position and a belief of many of my
- 8 peers that your plans to grant a multimillion-dollar
- 9 rate increase to People Gas is unwarranted and
- 10 unacceptable.
- I have been a service worker, I have
- 12 families members who are service workers, and I've
- 13 studied the plight of service workers in my research.
- 14 I know the majority of new jobs in Chicago are in the
- 15 service sector. These jobs by and large are low pay
- 16 with no benefits. According to the Department of
- 17 Housing and Urban Development, the lowest-income
- 18 workers spend on average over 12 percent of their
- 19 income on utilities. Worse still, households in
- 20 Illinois of retired service workers and other seniors
- 21 dependant on Social Security incomes spend an average
- 22 of 25 percent of their income on utilities. If we

- 1 have to give another \$12 or more a month to Peoples
- 2 Gas, that means a significant additional percentage
- 3 of our income it spent on utilities. That would mean
- 4 that to keep the heat on in our homes, we have to
- 5 take money that we spend on rent, food,
- 6 transportation, prescriptions and sacrifice any of
- 7 those needs in order to further grandiose the
- 8 shareholders of Peoples Gas.
- 9 As the ICC, you have the role and the
- 10 responsibility to regulate utilities to ensure they
- 11 are affordable and available to all citizens. To
- 12 grant another rate increase would clearly contradict
- 13 your mandate, utilities will become even more
- 14 unaffordable and therefore unavailable to more
- 15 people. Your decision on this rate increase will
- 16 affect the lives of hundreds of thousands of working
- families in Chicago, and I urge you to reject the
- 18 rate increase and roll back the rates.
- 19 Thank you.
- 20 CHAIRMAN BOX: Thank you.
- Once again, Ms. Jacqui Abrams.
- 22 (No response.)

- Once again, thank you to all of you
- 2 for your remarks.
- Moving into today's agenda, first of
- 4 all, we're holding Item 12, although we will be
- 5 discussing it.
- 6 Item 1 is Docket 08-0312. This is an
- 7 Original Cost Audit for Commonwealth Edison Company.
- 8 Administrative Law Judges Hilliard and Haynes
- 9 recommended the Order approving the Original Cost
- 10 Audit.
- Is there a motion to enter the order?
- 12 COMMISSIONER ELLIOTT: So moved.
- 13 CHAIRMAN BOX: Is there a second?
- 14 COMMISSIONER FORD: I second.
- 15 CHAIRMAN BOX: It's been moved and seconded.
- 16 All in favor say aye.
- 17 (Chorus of ayes.)
- 18 Opposed?
- 19 (No response.)
- The vote is a 5-0. The Order is
- 21 entered. We will use this 5-0 roll call vote for the
- 22 remainder of the agenda unless otherwise noted.

- 1 Item 2 is Docket 09-0057.
- 2 Constellation NewEnergy, Inc., seeks confidential and
- 3 proprietary treatment of portions of its ARES
- 4 compliance report for 5 years. The order grants the
- 5 request, but only for 2 years. Administrative Law
- 6 Judge Hilliard recommends entering the Order.
- 7 Is there any discussion?
- 8 (No response.)
- 9 Any objections?
- 10 (No response.)
- 11 Hearing none, the Order is entered.
- 12 Item 3 is Docket 09-0306, et al.,
- 13 consolidated. These are petitions for interlocutory
- 14 review arising from the Ameren Illinois Utility's
- 15 rate case. The first petition is by Staff.
- 16 Administrative Law Judges Albers and
- 17 Yoder, would you please explain the Staff's position.
- 18 JUDGE YODER: Yes, Chairman. On the 2nd
- 19 Mr. Sackett's rebuttal testimony -- AIU moved to
- 20 strike Staff witness' rebuttal testimony wherein he
- 21 proposed a change in AIU's Rider T Storage Banking
- 22 Program. AIU already argued that in

- 1 Mr. Sackett's direct testimony he proposed future
- 2 workshops and changes to the Rider T Storage Banking
- 3 Program in AIU's next rate case. AIU argued that
- 4 this change in testimony prejudiced them in their
- 5 ability to properly prepare surrebuttal testimony.
- 6 Staff in a response maintains that
- 7 Mr. Sackett discussed in his testimony the issue of
- 8 storage cost allocation and pointed out discrepancies
- 9 between AIU's exhibits and the work papers. Staff
- 10 indicates and Mr. Sackett requested in this direct
- 11 testimony that AIU clarify their rationale and
- 12 indicate that Mr. Sackett's previously submitted data
- 13 requests to AIU to obtain information and
- 14 clarification only to receive some data the day
- 15 before Staff filed its direct case.
- 16 Staff indicates that the information
- 17 provided ended up being erroneous and subsequently
- 18 corrected it in AIU's rebuttal testimony. Therefore
- 19 staff maintains that Mr. Sackett's attempted to
- 20 elicit the correct information and once he received
- 21 the correct information, he then used that delayed
- information to modify the original proposal therefore

- 1 asked or argues that Mr. Sackett's change in his
- 2 testimony was proper based on the information he had
- 3 received. The ALJs granted Ameren's motion to strike
- 4 the portion of Mr. Sackett testimony regarding change
- 5 in the Rider T Storage Banking Program.
- 6 COMMISSIONER O'CONNELL-DIAZ: Tell me what was
- 7 the basis of that determination.
- 8 JUDGE YODER: Our basis was that was a new
- 9 determination. He had made a change from his direct
- 10 testimony. He indicated -- they were proposing a
- 11 change in this docket. He proposed in his direct
- 12 that there be teacher workshops held on this issue
- and proposed, I think, three possible changes to be
- 14 considered in the next rate case.
- 15 CHAIRMAN BOX: Judge, it's your motion. Your
- 16 recommendation is to deny the petition?
- 17 JUDGE YODER: Correct.
- 18 CHAIRMAN BOX: Is there a motion to deny the
- 19 Staff's petition for interlocutory review?
- 20 COMMISSIONER O'CONNELL-DIAZ: Move.
- 21 COMMISSIONER BOX: Is there a second?
- 22 COMMISSIONER ELLIOTT: I second.

- 1 COMMISSIONER BOX: It's been moved and
- 2 seconded.
- 3 Further discussion?
- 4 (No response.)
- 5 All in favor say aye.
- 6 (Chorus of ayes.)
- 7 Opposed?
- 8 (No response.)
- 9 The vote is 5-0. The Staff's petition
- 10 is denied.
- 11 Next there is a petition for
- 12 interlocutory review from Ameren Illinois Utilities.
- Judges Albers and Yoder, please
- 14 explain that one.
- JUDGE ALBERS: This is Judge Albers, I will be
- 16 handling that one.
- 17 When we prepared the schedule in this
- 18 matter, we had set December 2nd as the date for
- 19 Ameren's surrebuttal testimony out at least 7
- 20 business days before the hearing began on December
- 21 14th. In Ameren's surrebuttal that was received on
- 22 December 2nd, there was some discussion of other

- 1 postemployment benefit costs or OPEB costs and
- 2 certain defendant compensation expenses.
- 3 Staff argued on a motion to strike
- 4 that on those particular issues that that testimony
- 5 received on Ameren's surrebuttal was actually
- 6 responsive to Staff and Intervenor in the direct
- 7 testimony which was offered on September 28th. And
- 8 because of that response to the direct testimony of
- 9 Staff and Intervenors, Staff argued that OPEB and
- 10 defendant comp testimony should have been received in
- 11 Ameren's rebuttal in October. So instead of offering
- 12 it in October, it would have been responsive to
- 13 either Staff on direct, Ameren waited a month and a
- 14 half and offered it on December 2nd. And because
- they waited, Staff and Intervenor had no opportunity
- 16 to respond.
- 17 With regard to the OPEB testimony,
- 18 that's probably the easiest one to address. Ameren
- 19 argued that our framing of the OPEB testimony should
- 20 be flipped because they claim they're responding to
- 21 Staff's recommended adjustment in Staff's rebuttal
- 22 testimony. If you look at the record, while the CUB

- 1 and the AG, before we proposed that OPEB adjustment
- 2 in their direct testimony in September -- in Ameren's
- 3 rebuttal they acknowledged the Fed and the CUB-AG
- 4 proposed adjustment, but did not speak very much
- 5 about it. Only when Staff adopted and supported that
- 6 adjustment and, again, the same adjustment that
- 7 CUB-AG proposed, only when Staff and CUB supported
- 8 that adjustment in Staff's rebuttal did Ameren take
- 9 that seriously and offer much more discussion of it
- in their surrebuttal testimony.
- 11 So it appeared to us that given that
- it was the exact same adjustment made or proposed by
- 13 CUB-AG in their direct testimony, it appears to us
- 14 that Staff was correct that that surrebuttal
- 15 testimony really should have been offered in Ameren's
- 16 rebuttal in October. And so that's why we struck the
- 17 OPEB testimony, and I'll adjust note that CUB-AG
- 18 supports Staff's motion.
- 19 Concerning the defendant compensation
- 20 testimony, in Staff witness Ebrey's direct testimony,
- 21 she laid out what she would like to see from Ameren
- 22 to resolve her concerns about those expenses.

- 1 Specifically she wanted to see some indication that
- 2 the net benefit to ratepayers -- I'm sorry. Let me
- 3 rephrase that. She wanted to see that ratepayers
- 4 receive a net benefit in light of the costs
- 5 associated with the defendant compensation expenses
- 6 at issue and, again, it's just the subset of Ameren's
- 7 compensation package of expenses.
- 8 What Ameren sought in Theresa Ebrey's
- 9 direct testimony -- what Staff was looking for --
- 10 they addressed to some extent defendant compensation
- in their rebuttal, but waited until their surrebuttal
- 12 testimony in December to really provide what
- 13 Ms. Ebrey was looking for. Ms. Ebrey laid out in her
- 14 direct testimony what Staff was looking for resulted
- in what Ameren offered in their surrebuttal should
- 16 have been provided much earlier, which would have
- 17 given Staff and other parties an opportunity to
- 18 respond.
- 19 COMMISSIONER O'CONNELL-DIAZ: Judge Albers, was
- 20 there a data request with regard to this information
- 21 propounded by Staff and the Company during the
- 22 discovery of the case?

- 1 JUDGE ALBERS: Yes.
- 2 COMMISSIONER O'CONNELL-DIAZ: And...?
- 3 JUDGE ALBERS: We addressed that in her
- 4 rebuttal testimony -- actually it was in her direct
- 5 testimony that she indicated that she had gotten a
- 6 response from Ameren, but didn't find it terribly
- 7 helpful.
- 8 COMMISSIONER O'CONNELL-DIAZ: Did she do a
- 9 follow-up data request, which would be normal if you
- 10 needed further information?
- JUDGE ALBERS: I want to say, yes, but I'm not
- 12 a hundred percent certain. It wasn't put in the
- 13 record. We wouldn't have seen it anyway.
- 14 COMMISSIONER O'CONNELL-DIAZ: Well, I
- 15 understand that; but that's kind of what discovery is
- 16 about.
- 17 CHAIRMAN BOX: Any other questions of the
- 18 Judge?
- 19 (No response.)
- 20 Judge, what is your recommendation?
- JUDGE ALBERS: We continue to believe that the
- 22 decision to strike the testimony was appropriate.

- 1 CHAIRMAN BOX: Is there a motion to deny the
- 2 Ameren Illinois Utility's interlocutory review?
- 3 COMMISSIONER ELLIOTT: So moved.
- 4 CHAIRMAN BOX: Is there a second?
- 5 COMMISSIONER COLGAN: Second.
- 6 CHAIRMEN BOX: It's been moved and seconded.
- 7 Any further discussion?
- 8 (No response.)
- 9 All in favor say aye.
- 10 (Chorus of ayes.)
- 11 Opposed?
- 12 COMMISSIONER O'CONNELL-DIAZ: I vote no.
- 13 CHAIRMAN BOX: The vote is 4-1. Ameren
- 14 Illinois Utility's petition is denied.
- 15 Items 4 through 11 will be taken
- 16 together. These are applications for ABC licenses.
- 17 ALJ Yoder recommends entering the Orders granting the
- 18 certificates.
- 19 Is there any discussion?
- 20 (No response.)
- 21 Any objections?
- 22 (No response..)

- 1 Hearing none, the Orders are entered.
- 2 If I can skip down, Items 13 and 14
- 3 will be taken together. These are petitions by
- 4 Marion County and Clay County to modify their 9-1-1
- 5 system. Administrative Law Judge Jones recommends
- 6 entering the Orders approving the modifications on
- 7 the condition that 9-1-1 callers will experience no
- 8 interruption of 9-1-1 service.
- 9 Is there any discussion?
- 10 (No response.)
- 11 Any objections?
- 12 (No response.)
- 13 Hearing none, the Orders are entered.
- Going back to Item 12, which is
- 15 09-0166 and 09-0167 consolidated. This is the North
- 16 Shore Gas Company and Peoples Gas Light and Coke
- 17 Company general rate case.
- 18 The Commission will be voting this out
- 19 at its bench session January 21st. Administrative
- 20 Law Judges Moran and Haynes are here to answer any
- 21 further questions the Commissioners may have.
- 22 Any other questions of the Judges?

- 1 We acknowledge receipt of your
- 2 responses. My one question was on the Accelerated
- 3 Rider ICR, would it be from dollar one or would it be
- 4 just the incremental amount of the replacement of
- 5 mains that would be covered in the Rider? If I'm
- 6 understanding, your memo indicated that it would be
- 7 from the first dollar and not the incremental amount;
- 8 is that correct?
- 9 JUDGE MORAN: Yes, that is correct; but there's
- 10 an explanation for that.
- 11 CHAIRMAN BOX: Give us a short explanation.
- 12 JUDGE MORAN: The short explanation is that the
- 13 Company proposed an incremental the last time this
- 14 was being proposed in the rate case 07-0241/0242.
- 15 Staff came out with a different proposal and
- 16 therefore the Company went with Staff's proposal.
- 17 That carried through to this proposal and there is no
- 18 recommendation in this record for any other based on
- 19 type provision.
- 20 CHAIRMAN BOX: So the Rider, once it's used,
- 21 would include the entire amount of the main
- 22 replacement rather than -- it includes that which was

- 1 scheduled anyway without the Rider and with the
- 2 accelerated portion.
- JUDGE MORAN: Well, it would start with
- 4 whatever is spent in 2011. You don't count the test
- 5 year and you don't count anything that they put into
- 6 the test year. It would start with 2011, anything
- 7 that goes into the ground or is estimated to go into
- 8 the ground in 2011. And it's only billed from April
- 9 to December and it's not the whole cost. You're just
- 10 collecting revenues associated with those costs.
- 11 CHAIRMAN BOX: Okay. Any further questions?
- 12 (No response.).
- 13 Once again this matter will be voted
- 14 on the bench session on the 21st. The statutory
- 15 deadline is January 25th.
- Judges, thank you.
- 17 That concludes today's agenda.
- Before we close I understand
- 19 Commissioner Ford has a resolution she would like to
- 20 offer.
- 21 Commissioner Ford.
- 22 COMMISSIONER FORD: Mr. Elliott would like to

- 1 make a recommendation.
- 2 COMMISSIONER ELLIOTT: Thank you. I think we
- 3 have a resolution and I would be pleased if
- 4 Commissioner Ford would read the resolution before I
- 5 make a motion.
- 6 COMMISSIONER FORD: The State of Illinois,
- 7 Illinois Commerce Commission on its own motion
- 8 acknowledging and express an appreciation for
- 9 Chairman Charles E. Box, public servant, on the
- 10 occasion of this separation of service with the
- 11 Commission resolution.
- 12 Whereas Chairman Charles E. Box on
- January 10th, 2006, began a noteworthy tenure as the
- 14 first African-American chairman of the Illinois
- 15 Commerce Commission. And whereas throughout Chairman
- 16 Charles E. Box's years at the Commission, he remained
- 17 on course, undeterred and truly subjective to strike
- 18 an even balance between utilities and the ratepayers
- 19 and to make that balance his top priority.
- 20 Whereas Chairman Charles E. Box served
- 21 as treasurer of the executive committee of the
- 22 National Association of Regulatory Utility

- 1 Commissioners. Whereas Charles E. Box on behalf of
- 2 the Illinois Commerce Commission and the United
- 3 States served as a regulatory expert to African and
- 4 European regulatory Commissions.
- 5 Whereas Charles E. Box, a dynamic
- 6 former Mayor of Rockford, Illinois, for 12 years has
- 7 diligently and thoughtfully served the people of the
- 8 State of Illinois in his capacity as Chairman.
- 9 Now therefore it be resolved that the
- 10 Illinois Commerce Commission here acknowledges
- 11 Charles E. Box's years of public service during his
- 12 employment with the Illinois Commerce Commission and
- 13 express a deep appreciation for his public service
- 14 and dedication on the occasion of his departure.
- 15 From your fellow Commissioners.
- 16 COMMISSIONER ELLIOTT: I would move adoption of
- 17 the resolution honoring our chairman.
- 18 CHAIRMAN COLGAN: I second the motion.
- 19 CHAIRMAN BOX: I was going to say, Guys, we're
- 20 lacking a second.
- 21 COMMISSIONER ELLIOTT: Moved and seconded.
- 22 All those in favor?

- 1 (Chorus of ayes.)
- 2 CHAIRMAN BOX: I would like to thank you for
- 3 the resolution. As most of you know, this is my last
- 4 meeting. My last day of work will be January 19th.
- 5 First of all, I would like to thank Governor
- 6 Blagojevich for giving me this opportunity in
- 7 January -- Commissioner Ford indicated January
- 8 of '06.
- 9 It's been an honor and a privilege to
- 10 serve in this capacity. Not only because of the
- 11 complex issues that are involved, but also at the
- 12 time. It was a very interesting time here in the
- 13 State of Illinois as far as regulation goes. And I
- 14 appreciated a chance to use my skills that I've
- 15 accumulated over the years in other avenues and other
- 16 opportunities.
- 17 I really want to thank my fellow
- 18 Commissioners who some of you have heard me say this
- 19 before at various Chicago Bar Association functions
- 20 that I really enjoy this work. I thought there was
- 21 nothing better and probably -- I must be honest,
- 22 there's nothing better than being mayor of your own

- 1 hometown, where you grew up and where you know people
- 2 and people know you. That was an exciting thrill.
- 3 This has to be a very close second
- 4 because of the Commissioners I've had an occasion to
- 5 work with, the Staff that I think is superb in this
- 6 day and age when your opponents are
- 7 multimillion-dollar law firms and people with
- 8 unlimited pockets for consultants and experts. You
- 9 have done an enormous job, and I don't think the
- 10 people of the State of Illinois realize the work that
- 11 the Commissioners do and the Commission Staff.
- I want to thank a lot of the parties
- 13 that have appeared before us for really representing
- 14 their clients well. I think at the end of the day
- 15 almost everyone here really tries to do what they
- 16 think is best. We have a very tough job here as a
- 17 lot of the speakers today said. You have to balance
- 18 the interest of the ratepayers and the ability to pay
- 19 with that of the companies and the ability for them
- 20 to earn a return on their moneys. And it's a tough
- 21 balancing act. None of these decisions are made
- 22 easily, and I really respect the Commissioners I work

- 1 with. They wrestle with these issues and they try to
- 2 make the best decisions they could. I can't say
- 3 enough about the Commissioners' assistants. I don't
- 4 ever think we've ever had a full 10 that were allowed
- 5 by statutes. There's never been an issue that has
- 6 come before us where those 6, 7, 8, or 9 people that
- 7 really didn't work long and hard. There's no such
- 8 thing as how many hours in a day. The key for us as
- 9 Commissioners is, if we want to get out a good
- 10 product, it's those assistants that we work with day
- in and day out and I can't say enough about them.
- 12 Once again, this has been a journey
- 13 that I have really enjoyed. I'm sure our paths will
- 14 be crossing somewhere down the road, if not in an
- official function, somewhere on the streets of the
- 16 City of Chicago or Washington D.C. or somewhere.
- 17 It's been a pleasure serving for these 4 years and
- 18 something I'll look back on and cherish. I want to
- 19 thank all of you for all of your input and the
- 20 Governor and Senator Jones who also had faith in me.
- 21 I appreciate his efforts and this will not be
- 22 forgotten. This is a journey that I have enjoyed and

- I hope that I've done the job that people thought I
- 2 could.
- 3 Thank you.
- 4 COMMISSIONER FORD: I'm certainly glad that you
- 5 thought that this was second to your being a mayor.
- 6 I do understand you are accustomed to being in the
- 7 hot seat because you have to hear complaints from
- 8 your constituents. It is very difficult, and I do
- 9 know that all of us do take it seriously and
- 10 certainly have enjoyed working with you these last 4
- 11 years.
- 12 CHAIRMAN BOX: With that, the meeting is
- 13 adjourned.

- proceedings had.)
