- 1 ACTING CHAIRMAN SHEAHAN: All right. Pursuant
- 2 to the provisions of the Open Meetings Act, I now
- 3 convene a special open meeting of the Illinois
- 4 Commerce Commission.
- 5 With me in Chicago are Commissioners
- 6 McCabe, del Valle and Maye. I am Chairman Sheahan.
- 7 We have a quorum.
- Before moving into the agenda,
- 9 according to Section 1700.10 of the Title 2 of the
- 10 Administrative Code, this is the time we usually
- 11 consider public comments.
- 12 Members of the public wishing to
- 13 address the Commission must notify the Chief Clerk's
- office at least 24 hours prior to Commission
- 15 meetings. According to the Chief Clerk's office, we
- 16 have no granted requests to speak at today's Bench
- 17 Session.
- 18 We will move on to the Public Utility
- 19 section of our agenda. We are going to take a
- 20 matter of other business out of order. We have
- 21 Mr. David Swain, President of Liberty Energy
- 22 Utilities (Midstates Natural Gas) Corp., d/b/a

- 1 Liberty Utilities to present the Company's Annual
- 2 Reorganization Report.
- Welcome, sir. The floor is yours.
- 4 PRESENTATION
- 5 BY
- 6 MR. SWAIN:
- 7 Good morning. Thank you for inviting
- 8 me to be here again today. I was here the last time
- 9 on October 23, 2013 to provide a first update to the
- 10 acquisition to Liberty Utilities and to provide a
- 11 brief update today as to how that acquisition is
- 12 going since then.
- First of all, on July 30, 2014 we
- 14 filed the reports that indicated total compliance
- and then, in addition, this presentation
- 16 today would be the final presentation under that
- 17 acquisition Order.
- One thing I would like to point out is
- 19 that since we have been operating as Liberty
- 20 Utilities we wanted to insure, and certainly you had
- 21 an expectation, that we would provide good customer
- 22 service, that we did that and we were able to

- 1 report.
- 2 So we have done two different customer
- 3 satisfaction surveys that compared us to the
- 4 benchmark of other utilities and both of those
- 5 summaries reported in an 85 percent customer
- 6 satisfaction growth for Liberty Utilities, and from
- 7 all indications we're on the road to set those
- 8 measurements that were considered best in class.
- 9 So we are very proud of that,
- 10 especially coming through two very cold winters that
- 11 we've had since being Liberty Utilities, so several
- 12 compliments to a lot of hard-working employees who
- 13 have made me to be able to say that today.
- In addition, if you are following
- 15 along at Page 5, it's always a pleasure for me to
- 16 brag on our front-line employees that's not just
- working for the utility but they provide good
- 18 leadership within the communities that they serve.
- 19 There's some pictures there of our employees that
- 20 are involved in current events after a tornado where
- 21 people lost their lives.
- 22 We were some of the first individuals

- on that scene and not only did the work that we were
- 2 required to do as a utility, they were there to help
- 3 that community in a lot of different ways, and then
- 4 you will see in the pictures after that, we were
- 5 still there to provide support and help them to
- 6 re-establish some funds that had been used and badly
- 7 needed today, so we helped with that.
- 8 The other pictures are of our
- 9 employees in the Harrisburg community. If you go
- 10 there, you will find that a lot of our employees are
- 11 providing leadership for the American Cancer Society
- 12 and recognized statewide as being leaders.
- In virtually every community that we
- 14 serve, our employees are providing leadership.
- They're a great asset to their communities, and it's
- 16 a great byproduct I think to have those kinds of
- 17 people working for Liberty Utilities. We are very
- 18 proud of them.
- In addition, on the next page you can
- 20 see that since we were required as part of eight
- 21 audits that were completed by the Pipeline Safety
- 22 Division, and there were no notices of violations,

- 1 and some of those were record audits and some of
- 2 those were field audits. We had to review our
- 3 O & M Manual, and all of those have now been
- 4 reviewed and in compliance and everybody has signed
- 5 off on those.
- In this business you recognize that
- 7 our first and foremost priority has to be safety and
- 8 I think out of safety, the byproduct becomes the
- 9 necessary reliability and certainly our customers
- 10 expect both of those.
- 11 One of the things that you I think
- 12 have seen, as evidenced by the audits, that we were
- 13 committed to that and I can assure you that as long
- 14 as we're Liberty Utilities that will remain a
- priority and we'll make sure that those systems
- operate safely, efficiently and that they continue
- 17 to be reliable.
- 18 We began last year in a ten-year Fiber
- 19 Replacement Plan in the state. We are planning to
- 20 replace all the bare steel, the ineffective utility
- 21 pipe and the PVC pipe within the state over that
- ten-year period. So we are making a substantial

- 1 capital investment and we are making replacements in
- 2 conjunction with our ten-year plan, so we are well
- 3 on our way to doing that and we'll continue that in
- 4 2015.
- 5 We believe that the acquisition has
- 6 been successful for Liberty Utilities and for its
- 7 customers in the communities. We are looking
- 8 forward to continue to provide service to those
- 9 customers, and if the opportunity arises, we hope to
- 10 add communities to our customer list.
- 11 And thank you for the opportunity and
- 12 the trust that you put in us to allow us to operate
- 13 this system. I'll be glad to answer any questions
- 14 that you might have.
- 15 ACTING CHAIRMAN SHEAHAN: Thank you.
- 16 Commissioners del Valle.
- 17 COMMISSIONER del VALLE: Thank you, Mr. Chairman.
- 18 On your customer satisfaction level,
- 19 the survey indicated 85 percent customer
- 20 satisfaction, and I know that there will always be a
- 21 customer out there who's not satisfied for some type
- of legitimate reason, and sometimes there are other

- 1 reasons, but could you tell me out of the 15 percent
- 2 what were the main issues or reasons, I should say,
- 3 for customer dissatisfaction, what steps are you
- 4 taking to address some of those?
- 5 MR. SWAIN: Yes. The survey is based on dozens
- of different questions, and so the compilation of
- 7 all those questions -- the answer to all those
- 8 brings up to the 85 percent mark.
- 9 I am personally familiar with some of
- 10 the small number of complaints that we have had.
- 11 Obviously, those customers were not satisfied with
- 12 us if they filed a complaint, most of which center
- 13 around our collection activities.
- 14 A customer would naturally be upset
- 15 because we disconnected their service, and that
- 16 would have been the result of not paying their bill,
- 17 and in every case that we have looked at we did
- 18 follow those rules. We did it according to the
- 19 questions that are already set, but, obviously, when
- 20 a customer's utilities are interrupted, they're not
- 21 always happy and I can tell you that over the last
- 22 winter we had many discussions about that and we

- 1 knew that some of our customer were going to be in a
- 2 bad spot because energy usages were up and bills
- 3 were higher, and we went above and beyond to try to
- 4 work with those customers.
- 5 What I can say if they tried -- if
- 6 they worked with us and they did their best, then we
- 7 did what we could to lead them along. Some
- 8 customers were upset about that.
- 9 There might have been some situations
- 10 where somebody thought that we were suppose to be
- 11 there when we made an appointment, although I can
- 12 tell you that those are few and far between. I do
- 13 know that probably over the last year a couple of
- 14 those situations where we made a commitment to be at
- 15 somebody's house and we didn't show up, and there's
- 16 two that I'm thinking of, as it were, were a result
- of a reconnect as a result of the customer being
- 18 shutoff for non-pay, but we had some communication
- issues with the CSR on the phone and said we will
- 20 get this back on, and once they communicated with
- 21 the field personnel, we had to go back on.
- 22 I know in at least one of those

- 1 situations we did that on a weekend. We made it
- 2 right, turned that customer back on. Those are a
- 3 couple of examples.
- 4 ACTING CHAIRMAN SHEAHAN: Thank you for your
- 5 response.
- 6 MR. SWAIN: Thank you.
- 7 ACTING CHAIRMAN SHEAHAN: Commissioner Maye.
- 8 COMMISSIONER MAYE: Thank you. Good morning,
- 9 Mr. Swain. Have you had any safety incidents in
- 10 internal or otherwise in the last year?
- 11 MR. SWAIN: Can you ask that again.
- 12 COMMISSIONER MAYE: I was curious to know whether
- or not you had any safety incidents internal or
- 14 otherwise.
- MR. SWAIN: We have not. Now on a day-to-day
- 16 basis we will receive calls from customers saying
- 17 they smell gas or that they have an issue with
- 18 pressure. Those come in on a daily basis. We
- 19 respond to those in a timely manner, but beyond
- 20 that, no, we have not had any others.
- 21 COMMISSIONER MAYE: Thank you.
- 22 ACTING CHAIRMAN SHEAHAN: Commissioner McCabe.

- 1 COMMISSIONER McCABE: Yes. I would like to ask
- 2 you about your Pipeline Replacement Program. At the
- 3 end of the ten-year program will all of the bare
- 4 steel and PVC pipe be replaced in your territory or
- 5 will those be remaining?
- 6 MR. SWAIN: Yes. We have planned over the next
- 7 ten years to replace all of that bare steel and PVC
- 8 pipe a hundred percent.
- 9 ACTING CHAIRMAN SHEAHAN: Any other questions?
- 10 (No response.)
- 11 Okay. Thank you, sir.
- 12 MR. SWAIN: Thank you.
- 13 ACTING CHAIRMAN SHEAHAN: We will turn now to our
- 14 electric portion of today's agenda, and we will
- begin with the approval of the minutes from
- 16 January 6th. I understand there was a Scribner's
- 17 error that was corrected and circulated.
- 18 Is there a motion to approve the
- 19 amendments with the correction of that Scribner's
- 20 error?
- 21 COMMISSIONER MAYE: So moved.
- 22 ACTING CHAIRMAN SHEAHAN: Is there a second?

- 1 COMMISSIONER McCABE: Seconded.
- 2 ACTING CHAIRMAN SHEAHAN: All those in favor, say
- 3 aye.
- 4 (Chorus of ayes.)
- 5 The Minutes of the January 6th open
- 6 meeting, as amended, are approved.
- 7 Item E-1 is Ameren-Illinois Company's
- 8 filings to revise its gas and electric tariff pages
- 9 governing eligibility for service, deposits, payment
- 10 practices, and discontinuance of electric and gas
- 11 service consistent with the recent Commission Order
- in Docket No. 06-0703 regarding 83 Illinois Code
- 13 Part 280. Staff recommends that we approve the
- 14 revisions by not suspending the filing.
- 15 Is there any discussion?
- 16 (No response.)
- 17 Is there a motion not to suspend the
- 18 filing?
- 19 COMMISSIONER McCABE: So moved.
- 20 ACTING CHAIRMAN SHEAHAN: Is there a second?
- 21 COMMISSIONER MAYE: Seconded.
- 22 ACTING CHAIRMAN SHEAHAN: All in favor, say aye.

- 1 (Chorus of ayes.)
- The motion carries 4 to 0 and the
- 3 filing is not suspended.
- 4 We will ask for leave for unanimous
- 5 consent for the following items: Item No. E-2 is
- 6 MidAmerican Energy Company's filing updating Rider
- 7 Energy Efficiency Cost Recovery (Rider EECR) to
- 8 include an information sheet and to comply with
- 9 Docket No. 13-0423/13-0424 (Consolidated).
- 10 Staff recommends that we approve the
- 11 update by not suspending the filing.
- 12 Is there any discussion?
- 13 (No response.)
- 14 Any objections?
- 15 (No response.)
- Without objection, the Order is
- 17 entered.
- 18 Item No. E-3 is our investigation into
- 19 the Customer Authorization Required for Access to
- 20 Third Parties Other Than Retail Electric Suppliers
- 21 to Advanced Metering Infrastructure Interval Meter
- 22 Data.

- 1 Staff recommends entry of an Order
- 2 initiating the investigation.
- Is there any discussion?
- 4 (No response.)
- 5 Any objections?
- 6 (No response.)
- 7 Hearing none, the Order is entered.
- 8 Item No. E-4 is Docket 12-0456. This
- 9 is our rulemaking proceeding to develop and adopt
- 10 rules concerning municipal aggregation.
- On June 11, 2014, the Commission
- 12 issued its Second Notice Order authorizing the
- 13 Proposed Rules to be submitted to the Joint
- 14 Committee on Administrative Rules ("JCAR") to begin
- 15 the Second Notice Period.
- At JCAR's October 14, 2014 meeting,
- 17 JCAR voted objection to, and prohibited the filings
- 18 of, the Proposed Rules.
- 19 Since that time, the parties to the
- 20 proceeding have suggested additional changes to the
- 21 Part 470 language to provide additional RES customer
- 22 protections. The language requires an additional

- 1 statement be included in the customer disclosure
- 2 sent to RES customers. It also requires that the
- 3 RES customer information not be retained by the
- 4 Aggregation Supplier and prohibits further use of
- 5 the information for marketing.
- 6 ALJ Haynes recommends entry of the
- 7 Post-prohibition Order and Appendix.
- 8 Is there any discussion?

- 10 Are there any objections?
- 11 (No response.)
- 12 Hearing none, the Order and Appendix
- 13 are entered.
- 14 Item E-5 is Docket 13-0527. This is
- 15 our Reconciliation of Revenues Collected under

- 18 ALJ Sainsot recommends entry of an
- 19 Order approving the reconciliation.

- 10 ACTING CHAIRMAN SHEAHAN: Is there any
- 11 discussion?
- 12 (No response.)
- 13 All those in favor of denying the
- 14 motion for rehearing, say aye.
- 15 (No response.)
- Opposed, say no.
- 17 COMMISSIONER del VALLE: No.
- 18 ACTING CHAIRMAN SHEAHAN: The vote is 3 to 1 and
- 19 the rehearing on the topic of AIP is denied.
- 20 Along with its Petition for Rehearing,
- 21 the Attorney General also filed a Motion for Partial
- 22 Collection of Revenues Subject to Refund which ALJs

- 1 Haynes and Teague-Kingsley recommend we grant in
- 2 part with regard to ADIT and deny in part with
- 3 regard to API.

- 16 Rehearing. The Attorney General has also filed a
- 17 Motion for Partial Collection of Revenues Subject to
- 18 Refund which ALJs Albers and Von Qualen recommend we
- 19 grant.
- Is there a motion to grant the motion
- 21 consistent with the ALJs recommendation?
- 22 COMMISSIONER del VALLE: So moved.

- 1 ACTING CHAIRMAN SHEAHAN: Is there a second?
- 2 (No response.)
- There's no second.
- 4 So, for the lack of a second, we will
- 5 not take any action on Docket No. 14-0317.
- 6 COMMISSIONER MAYE: Mr. Chairman, if I may, I
- 7 would like to move to deny the motion.
- 8 COMMISSIONER McCABE: Seconded.
- 9 ACTING CHAIRMAN SHEAHAN: Is there any
- 10 discussion?

- 21 COMMISSIONER MAYE: Denied.
- 22 ACTING CHAIRMAN SHEAHAN: Denied. So I thank

- 1 you.
- 2 Moving on to other business, we have
- 3 two remaining items of other business on today's
- 4 agenda. The first is the ICC's 2014 Annual Report
- on Gas, Electricity and Water.

- 10 All in favor, say aye.
- 11 (Chorus of ayes.)
- 12 Opposed, say no.
- 13 (No response.)
- 14 The vote is 4 to 0 to go into closed
- 15 session, and we just ask to clear the room.

- 17 44 are contained in a
- 18 separate transcript for
- 19 Closed Session)
