- 1 CHAIRMAN SCOTT: Is everyone ready in
- 2 Springfield?
- 3 COMMISSIONER COLGAN: We're ready to go.
- 4 CHAIRMAN SCOTT: Pursuant to the provisions of the
- 5 Open Meetings Act, I now convene a regularly scheduled
- 6 bench session of the Illinois Commerce Commission. With
- 7 me in Chicago are Commissioner McCabe, Commissioner del
- 8 Valle, and Commissioner Maye. In Springfield is
- 9 Commissioner Colgan. I am Chairman Scott. We have a
- 10 quorum.
- Before moving into the agenda, according to
- 12 Section 1700.10 of Title 2 of the Administrative Code,
- 13 this is the time we allow members of the public to
- 14 address the Commission. Members of the public wishing
- 15 to address the Commission must notify the Chief Clerk's
- 16 Office at least 24 hours prior to Commission meetings.
- 17 According to the Chief Clerk's office, we have no
- 18 requests to speak at today's bench session.
- Moving to Transportation, we'll start with the
- 20 railroad portion of today's agenda:
- 21 Item RR-1 is Docket No. T13-0088. This is the
- 22 Department of Transportation, on behalf of the People of
- 23 the State of Illinois', their petition for approval of
- 24 the taking or damaging of certain properties owned by a
- 25 transportation common carrier in DuPage County by

- 1 exercising the right of eminent domain. ALJ Duggan
- 2 recommends entry of an Order approving the use of
- 3 eminent domain.
- 4 Is there any discussion?
- Is there a motion to enter the Order?
- 6 COMMISSIONER McCABE: So moved.
- 7 CHAIRMAN SCOTT: Moved by Commissioner McCabe.
- 8 Second?
- 9 COMMISSIONER MAYE: Second.
- 10 CHAIRMAN SCOTT: Seconded by Commissioner Maye.
- 11 Any discussion?
- 12 All in favor say aye.
- 13 (Ayes heard.)
- 14 CHAIRMAN SCOTT: Any opposed?
- 15 (No response.)
- 16 CHAIRMAN SCOTT: The vote is 5-0 and the Order is
- 17 entered. We will use this 5-0 vote for the remainder of
- 18 today's transportation agenda unless otherwise noted.
- 19 Item RR-2 is Docket No. T13-0128. This is the
- 20 Indiana Railroad Company, the Village of Oblong, the
- 21 City of Robinson and IDOT's stipulated agreement
- 22 regarding safety improvement at a highway rail grade
- 23 crossing in Crawford County. Our transportation counsel
- 24 recommends entry of an Order approving the agreement.
- Is there any discussion?

- 2 (No response.)
- 3 CHAIRMAN SCOTT: Hearing none, the Order is
- 4 entered.
- 5 Moving now to Motor Carriers, Item MC-1, Shawn
- 6 Bradley-Shimizu's application for an operator's
- 7 employment permit under Chapter 625 ILCS 5/18a-403 of
- 8 the Illinois Commercial Relocation of Trespassing
- 9 Vehicles Law. ALJ Kirkland-Montaque recommends entry of
- 10 an Order granting the application.
- 11 Is there any discussion?
- I would like to propose edits to this Order.
- 13 These edits reverse the conclusion, thereby denying
- 14 Mr. Bradley-Shimizu's application for an operator's
- 15 permit. They also add language recommending the
- 16 applicant return for certification after he has
- 17 completed the terms of his probation. I believe this is
- 18 consistent with the Commission's actions on these
- 19 matters in the past. We have two serious crimes, one
- 20 involving violence; one involving theft that happened
- 21 fairly recently and the gentleman is still on parol
- 22 for -- excuse me, probation for another year. So with
- 23 that, I would move the adoption of these edits.
- Is there a second?
- 25 COMMISSIONER MAYE: Second.

- 1 CHAIRMAN SCOTT: Seconded by Commissioner Maye.
- 2 Commissioner del Valle?
- 3 COMMISSIONER del VALLE: Question for ALJ, what is
- 4 the fee for applying for the permit?
- 5 JUDGE MONTAQUE: \$50.
- 6 COMMISSIONER del VALLE: Okay. And when this
- 7 person after they complete the probationary period comes
- 8 in to apply again, they'll pay another \$50?
- 9 JUDGE MONTAQUE: Correct.
- 10 COMMISSIONER del VALLE: I'm not looking for
- 11 answers here today because I think it's something we
- 12 need to explore. And I agree -- and we're voting for
- 13 favor of the edit, but I'm concerned that even though in
- 14 the law we don't indicate that if you're on probation
- 15 you will be denied a permit or in our rules we don't
- indicate that if you're on probation, you'll be denied a
- 17 permit. It is basically a decision that we've made as a
- 18 commission to -- and one that I agree with and I fully
- 19 support, but I think it's just a bit unfair to allow
- 20 someone to apply and not let them know that they're
- 21 going to lose their 50 bucks because they're on
- 22 probation. So I'm wanting to explore how is it that we
- 23 can approach it -- how is it that we can inform people
- 24 so that doesn't happen? Because if they successfully
- 25 complete their probationary period, we're more than

- 1 likely -- we're likely, not a guaranteed, depending on
- 2 the circumstances, to approve it. So I'd like for us to
- 3 think about that and explore that.
- 4 JUDGE MONTAQUE: Okay.
- 5 CHAIRMAN SCOTT: There may be something to do
- 6 too -- Just thinking this off the top of my head, it may
- 7 be something to do, too, with the fee itself. And if
- 8 they come back, you know, to do something with the fee
- 9 rather than another 50 -- we have costs that are
- 10 involved in that. We've already done a lot of the
- 11 preparatory work on an applicant. If it gets to this
- 12 point, so, you know, perhaps we could make the argument
- 13 that we're not doing as much so we can do an
- 14 adjustment --
- 15 COMMISSIONER del VALLE: That's the type of thing
- 16 I'd like to explore.
- 17 CHAIRMAN SCOTT: Because the only concern I have is
- 18 that I think we have granted some folks who were on
- 19 probation for a long period of time that we granted --
- 20 and I don't know that I necessarily want to box
- 21 ourselves in -- You know, if the statute says it, that's
- 22 one thing, but just on a case-by case basis, I think I
- 23 want to leave us that flexibility.
- COMMISSIONER del VALLE: Yes, and I agree with
- 25 that. I recall that case where we made an exception to

- 1 our own practice. But that was one. It's the only one
- 2 that I could recall. So if we could just explore that,
- 3 I'd appreciate it.
- 4 CHAIRMAN SCOTT: Thank you. Commissioner Colgan?
- 5 COMMISSIONER COLGAN: Yeah, I'm not going to
- 6 support the edit. I think you made a comment that this
- 7 was consistent with our previous decisions. I'm not
- 8 sure that it is; in the sense I remember we voted for a
- 9 situation like this to deny the application of a person
- 10 who is on probation, but that person had another job.
- 11 They had a job in Missouri. And in this case, denying
- 12 this application basically takes this man's job away,
- 13 and he's in compliance with his terms of his probation.
- 14 I agree that it's -- both issues are serious issues, but
- 15 he is in compliance with his probation, and now he's not
- 16 going to have a job. So I'm going to vote no.
- 17 CHAIRMAN SCOTT: Further discussion? The motion is
- 18 moved and seconded to support the edits as I proposed
- 19 them. All in favor say Aye.
- 20 (Ayes heard.)
- 21 CHAIRMAN SCOTT: Opposed?
- MR. COLGAN: No.
- 23 CHAIRMAN SCOTT: The vote is 4-1 and the edits are
- 24 adopted. Is there now a motion to enter the order as
- amended?

- 1 COMMISSIONER MAYE: So moved.
- 2 CHAIRMAN SCOTT: Moved by Commissioner Maye.
- 3 Is there a second?
- 4 COMMISSIONER McCABE: Second.
- 5 CHAIRMAN SCOTT: Seconded by Commissioner McCabe.
- 6 All in favor say Aye.
- 7 (Ayes heard.)
- 8 CHAIRMAN SCOTT: Opposed?
- 9 COMMISSIONER COLGAN: No.
- 10 CHAIRMAN SCOTT: Vote is 4-1 and the Order as
- 11 amended is entered, and the application as denied.
- 12 Item MC-2 is Deckster Coorsen's application
- 13 for an operator's employment permit under Chapter 625
- 14 ILCS, Section 5/18a-403 of the Illinois Commercial
- 15 Relocation of Trespassing Vehicles Law. ALJ Duggan
- 16 recommends entry of an Order granting the application.
- 17 Is there any discussion?
- 18 COMMISSIONER MAYE: Yes.
- 19 CHAIRMAN SCOTT: Commissioner Maye ...
- 20 COMMISSIONER MAYE: The edits that I'm proposing to
- 21 this Order amended to provide more detail as to the
- 22 applicant's criminal background history. I found the
- 23 language in the Order indicating the applicant had no
- 24 pertinent convictions quite vague. While I understand
- 25 the commission strives to protect the privacy of

- 1 applicants, I think it's essential that the Commission
- 2 be provided with the details necessary to determine
- 3 whether or not a particular charge or conviction is
- 4 pertinent to the underlying decision. As such, these
- 5 edits include mention of the conviction of the
- 6 applicant's criminal background check records. Going
- 7 forward, I would urge all ALJs to provide the Commission
- 8 with as much information as possible in these cases.
- 9 With that, I move the adoption of these edits.
- 10 CHAIRMAN SCOTT: The edits have been moved. Is
- 11 there a second?
- 12 COMMISSIONER del VALLE: Second.
- 13 CHAIRMAN SCOTT: Seconded by
- 14 Commissioner del Valle.
- Any discussions on the edits?
- 16 COMMISSIONER MAYE: Excuse me, I just want to
- 17 mention I did have collaboration with Mr. Del Valle's
- 18 office. My apologies.
- 19 CHAIRMAN SCOTT: Any further discussion?
- 20 All in favor of the edits vote aye.
- 21 (Ayes heard.)
- 22 CHAIRMAN SCOTT: Opposed?
- 23 (No response.)
- 24 CHAIRMAN SCOTT: The vote is 5-0 and the edits are
- 25 adopted. Is there now a motion to enter the Order as

- 1 amended?
- 2 COMMISSIONER McCABE: So moved.
- 3 CHAIRMAN SCOTT: Moved by Commissioner McCabe.
- 4 Is there a second?
- 5 COMMISSIONER MAYE: Seconded by Commissioner Maye.
- 6 CHAIRMAN SCOTT: Any discussion? All in favor say
- 7 aye.
- 8 (Ayes heard.)
- 9 CHAIRMAN SCOTT: The vote is 5-0 and the Order as
- 10 amended is entered.
- On to collateral recovery. Item CR-1 is
- 12 granted Brandon Canales' application for a Class EE
- 13 recovery permit pursuant to Section 45 of the Collateral
- 14 Recovery Act. ALJ Duggan recommends entry of an order
- 15 granting the application.
- Is there any discussion?
- 17 (No response.)
- 18 CHAIRMAN SCOTT: Are there any objections?
- 19 (No response.)
- 20 CHAIRMAN SCOTT: Hearing none, the Order is
- 21 entered.
- 22 Item CR-2 is Charles Durkin's application for
- 23 a Class EE Recovery Permit pursuant to Section 45 of the
- 24 Collateral Recovery Act. ALJ Duggan recommends entry of
- 25 an Order granting the application. This item will be

- 1 held for disposition of a future Commission proceeding.
- 2 Is there any discussion on that item before we
- 3 move?
- 4 Mr. Matrisch, is there any further transportation
- 5 business before the commission today?
- 6 MR. MATRISCH: No, Chairman. Thank you.
- 7 CHAIRMAN SCOTT: Thank you, sir.
- 8 Hearing none, this concludes today's
- 9 Transportation Agenda.
- 10 Moving on now to the Public Utility agenda.
- 11 We will begin with approval of minutes from our January
- 12 7th Regular Open Meeting. I understand amendments have
- 13 been forwarded. Is there a motion to approve the
- 14 amendment?
- 15 COMMISSIONER McCABE: Move.
- 16 CHAIRMAN SCOTT: Moved by Commissioner McCabe.
- 17 Second?
- 18 COMMISSIONER MAYE: Second.
