- 2 Are we ready to proceed in
- 3 Springfield?
- 4 MR. MATRISCH: Yes, we are.
- 5 CHAIRMAN SHEAHAN: Pursuant to the Open Meetings
- 6 Act, I call March 9, 2015 Special Open Meeting of
- 7 the Illinois Commerce Commission to order.
- 8 Commissioners del Valle and Maye are
- 9 present with me in Chicago, and we have a quorum.
- 10 We should also have Commissioner McCabe available on
- 11 the phone.
- 12 Commissioner, are you with us?
- 13 COMMISSIONER McCABE: I am.
- 14 CHAIRMAN SHEAHAN: Thank you.
- 15 I would like to move that we allow
- 16 Commissioner McCabe to participate by phone.
- 17 Is there a second?
- 18 COMMISSIONER del VALLE: Seconded.
- 19 CHAIRMAN SHEAHAN: All those in favor, say aye.
- (Chorus of ayes.)
- Opposed, say no.
- 22 (No response.)

- 1 Motion carries. Thank you.
- We have no public comments and,
- 3 therefore, we will move right into our agenda. We
- 4 have one item on our Special Open Meeting agenda
- 5 which concerns the Village of Elmwood's Petition for
- 6 the Installation of a Highway Grade Crossing and the
- 7 Closure of the Existing Grade Crossing in Will
- 8 County. Both IDOT and CenterPoint Intermodal, LLC,
- 9 have filed a petition for rehearing of the ALJ's
- 10 Interim Order in this case.
- I would like to make a motion to grant
- 12 IDOT's Petition for Rehearing in part for the
- 13 purpose of taking additional evidence from IDOT and
- 14 to deny IDOT's request to withdraw the Proposed
- 15 Interim Order until the rehearing is complete.
- 16 Given the legitimate safety concerns
- 17 relating to the crossing that were raised during the
- 18 initial hearings, we don't believe it's appropriate
- 19 to reopen the crossing at this time.
- Is there a second?
- 21 COMMISSIONER MAYE: Seconded.
- 22 CHAIRMAN SHEAHAN: Is there any further

- 1 discussion?
- 2 Commissioner del Valle.
- 3 COMMISSIONER del VALLE: Thank you, Mr. Chairman.
- 4 I agree with the parties and the ALJ
- 5 that argue that the rehearing request should be
- 6 denied. The alleged new evidence of traffic
- 7 outcomes at the crossing's closure was addressed or
- 8 raised in the rider, and IDOT had an opportunity to
- 9 raise the issue and to cross-examine on the issue.
- 10 IDOT elected not to do so.
- 11 The Interim Order with this evidence
- in the record still follow the safety needs and
- 13 merit the closing or closure of the crossing. I do
- 14 not believe that the requirements for rehearing have
- been met, and we will be voting on it.
- 16 CHAIRMAN SHEAHAN: Any further discussion?
- 17 (No response.)
- 18 Okay. All those in favor of granting
- 19 IDOT's petition for rehearing in part and denying in
- 20 part, say aye.
- 21 (Chorus of ayes.)
- Opposed, say no.
