- 3 Item 7 concerns our investigation of
- 4 Standard Terms for Customer Authorization of Access
- 5 to Interval Usage Data for Non-Billing Purposes.
- I understand that Commissioner McCabe
- 7 has some questions for the ALJ.
- 8 ALJ Kimbrel, just state your name for
- 9 the record.
- 10 JUDGE KIMBREL: Ethan Kimbrel.
- 11 CHAIRMAN SHEAHAN: Thanks for being here.
- 12 Commissioner.
- 13 COMMISSIONER McCABE: The customer authorization
- language that's in the appendix defined in the Order
- 15 say that the authorization language established by
- 16 this Order will be used by RESs to access customer
- 17 interval usage data.
- 18 I was wondering if the language in the
- 19 appendix is final and will be in place for a certain
- 20 amount of time or if it can be modified and whether
- 21 it was tested in any kind of focus groups with
- 22 actual customers.

- 1 JUDGE KIMBREL: Commissioner, that language was
- 2 developed in the workshops, and then the unresolved
- 3 issues came before me in the docket and then I
- 4 decided those issues.
- 5 Regarding whether that language will
- 6 be permanent, Staff is going to file a report a year
- 7 from today's Order and see whether or not the
- 8 language was successful. If it is successful, then
- 9 there will be measures to make the language
- 10 permanent in the applicable codes. And if they
- don't feel that it is, they will recommend an
- 12 alternative authorization language in Staff's
- 13 report.
- 14 COMMISSIONER McCABE: Okay. My only concern if
- this language is to encourage folks to say, yes, I'm
- 16 not sure if it can achieve that goal.
- 17 CHAIRMAN SHEAHAN: Thank you.
- 18 Any other questions or comments?
- 19 Commissioner del Valle, do you have --
- 20 COMMISSIONER del VALLE: I have an edit.
- 21 CHAIRMAN SHEAHAN: -- an edit?
- 22 COMMISSIONER del VALLE: Thank you, Mr. Chairman.

- 1 First of all, I must say that I fully concur with
- 2 Commissioner McCabe on the language of the
- 3 authorization form. I think that it's going to need
- 4 some work. We were having a real challenge in this
- 5 business of explaining things to people in plain
- 6 language, which I realize the lawyers play a role in
- 7 putting together the language, and it's always the
- 8 utilities and their representatives. It's been
- 9 their purpose of making sure that every one is
- 10 protected, but when you are dealing directly with
- 11 the customer, we have to find a way of making sure
- 12 that they understand fully what it is that they are
- 13 providing their authorization for.
- So I agree with Commissioner McCabe
- 15 that it will need some work in some form, but I do
- 16 have an edit. My edits can be found at Sections G
- 17 and H of the Order regarding third-party affiliates
- 18 on Pages 12, 13 and 14.
- The appendix is amended accordingly
- 20 and non-substantive edits have also been recommended
- 21 by myself and Commissioner McCabe as well throughout
- 22 the document.

- 1 Section G addresses the authorization
- 2 language regarding the disclosure of usage
- 3 information to third parties by RESs.
- 4 Section 8 addresses the disclosure of
- 5 RES affiliates. The edits to the conclusion explain
- 6 that although the authorization should permit
- 7 disclosure of the data to its contracted third
- 8 parties and affiliates, it should also clearly
- 9 foreclose the authorization to sell or license the
- 10 electric usage information by RESs or its contracted
- 11 agent to any party contracted or not.
- 12 Maintaining the principle that these companies
- 13 should not be able to profit from access to this
- 14 customer data, it concludes that Staff's language
- 15 fail to accomplish this, instead the edits adopt the
- 16 following language. RESs may disclose the EUI to
- 17 contracted third-party vendors or affiliates for
- 18 this purpose only.
- 19 RESs, its affiliates and its
- 20 contracted third-party vendors, will not sell or
- 21 license DUI to any party for any purpose. This
- language explains to the customer the scope of the

- 1 authorization that is being granted, and, as I
- 2 indicated earlier, I agree that that will probably
- 3 need some work down the road and the limits placed
- 4 on the RESs and its agents by the authorization.
- 5 With that, I move the adoption of this
- 6 edit.
- 7 CHAIRMAN SHEAHAN: Is there a second?
- 8 COMMISSIONER McCABE: Seconded.
- 9 CHAIRMAN SHEAHAN: Any discussion on the edits?

- 2 Rates and Accounting Entries.

- 11 COMMISSIONER McCABE: Thank you. April is "Call
- 12 Before you Dig Month." Illinois is a leader in the
- 13 campaign to spread awareness of the one-call number,
- 14 811.
- 15 A call to JULIE, Inc., which is the
- 16 Joint Utility Locating Information for Excavators,
- 17 provides excavators and underground utility owners a
- 18 one-call message handling and delivery service to
- 19 protect our underground pipelines, cables and
- 20 wiring, as well as the health and safety of those
- 21 working or living near them.
- JULIE, Inc., covers the state outside

- of the city limits of Chicago, has nearly 100
- 2 employees, and receives 1.2 million locate calls
- 3 annually.
- 4 Illinois law requires all homeowners
- 5 and contractors, prior to digging, to call 811, so
- 6 that underground utility lines can be marked,
- 7 whether you are planting trees or doing major
- 8 construction.
- 9 In 2014, ICC Staff issued 125 warnings
- and 86 citations resulting in almost \$83,000 in
- 11 penalties for not having a valid locate request, not
- 12 digging carefully around marked underground utility
- 13 facilities and for utilities failing to mark their
- 14 facilities in a timely manner.
- 15 A proclamation from Governor Rauner
- 16 declaring April "Call Before you Dig Month" in
- 17 Illinois is on display on the first floor of the
- 18 Commission office in Springfield.
- The Commission supports safety around
- 20 utility lines and urges excavators and homeowners to
- 21 call 811 before digging.
- I move the adoption of a resolution

- 1 recognizing April 2015 as "Call Before You Dig
- 2 Month" in Illinois.
- 3 CHAIRMAN SHEAHAN: Is there a second?

- 15 transition from one chairman to another, and I'm
- 16 grateful for their service and their help, and so we
- just want to thank you again for your service to the
- 18 Commission and the People of Illinois. Thank you
- 19 for everything you have done.
- 20 Is there any other new business before
- 21 the Commission?
- 22 COMMISSIONER ROSARIO: Excuse me. I would like
