PROCEEDINGS

CHAIRMAN SCOTT: Pursuant to the provisions of the Open Meetings Act, I now convene a regularly scheduled Bench Session of the Illinois Commerce Commission. With me in Springfield are Commissioner Colgan, Commissioner McCabe, and Commissioner Maye. With us in Chicago is Commissioner del Valle. I am Chairman Scott and we have a quorum.

Before moving into the agenda, according to Section 1700.10 of Title 2 of the Administrative Code, this is the time we allow members of the public to address the Commission. Members of the public wishing to address the Commission must notify the Chief Clerk's office at least 24 hours prior to Commission meetings. According to the Chief Clerk's office, we have no requests to speak at today's Bench Session.

Moving now to the Transportation Agenda, we'll begin with the approval of minutes from our March 19th Bench Session. I understand amendments have been forwarded.

16 McCabe. Second by Commissioner Colgan.

18 (Chorus of ayes.)
19 CHAIRMAN SCOTT: Any opposed?
20 (No response.)
21 CHAIRMAN SCOTT: The vote is five to
22 nothing, and the minutes from our March 19th Bench
23 Session, as amended, are approved.
24 Items RR-1 through RR-3 can be taken

1 together. These items are Stipulated Agreements
2 seeking authorization for safety improvement projects
3 at highway-rail grade crossings in counties across
4 Illinois. In each case, our Transportation counsel
5 recommends entry of an Order approving the Stipulated
6 Agreement.

11 CHAIRMAN SCOTT: Is there a motion to enter
12 the Orders?

6 Items RR-4 through RR-6 can be taken
7 together. These items are petitions for
8 authorization to construct or replace at-grade
9 pedestrian crosswalks in McLean County. In each
10 case, ALJ Kirkland-Montague recommends entry of an
11 Order granting the requested relief.

16 CHAIRMAN SCOTT: Hearing none, the Orders
17 are entered.

18 Item RR-7 is Docket Number T11-0139. This

21 structure in DuPage County. IDOT has filed a
22 petition for a Supplemental Order requesting a time
23 extension, which ALJ Duggan recommends we grant.

5 Supplemental Order is entered.

6 Item MC-1 is Docket Number 138978 MC. This

9 Commission authority. Settlement has been reached
10 and our Transportation counsel recommends entry of an
11 Order accepting the Stipulated Settlement Agreement.

16 CHAIRMAN SCOTT: Hearing none, the Order is
17 entered.

18 Item MC-2 is Richard Andes Sr.'s Application

21 Relocation of Trespassing Vehicles Law. ALJ
22 Kirkland-Montague recommends entry of an Order
23 granting the Application.
