- 14 need more attention.
- Some of the complaints we continue to
- 16 receive include marketing personnel implying or
- 17 stating outright that their company is sponsored by
- 18 ComEd; pressure at the door and over the phone to
- 19 produce a ComEd bill with account number before the
- 20 product is explained; the use of scare tactics, some
- 21 very outrageous, and I won't get into those; refusal
- to leave written information identifying the company

- 1 for the customers to review before agreeing to
- 2 transfer; and one of the most important ones,
- 3 misleading or erroneous information regarding rates
- 4 as well as customers not understanding the letter of
- 5 agency.
- We, as the Commission, certify these
- 7 retail electric suppliers, and I think it's important
- 8 that our Commission carefully look at the growing
- 9 number of complaints and address them in some way.
- 10 Thank you.
- 11 CHAIRMAN SHEAHAN: Thank you, Commissioner. I
- 12 think we all share those sentiments. And we've been
- exploring ways, vehicles for bringing those concerns
- 14 to the Commission and we'll do that quickly. So
- 15 thank you.
