- 2 have 1:30.
- 3 Under the Open Meetings Act, I call
- 4 the July 8th, 2021 Special Open Meeting to order.
- 5 Commissioners Bocanegra, Carrigan and Kimbrel are
- 6 with me in Springfield. We have a quorum with
- 7 all four commissioners present.
- 8 We have no requests to speak. There
- 9 is no transportation agenda. So we are moving
- 10 right on to our Public Utilities Agenda with only
- 11 one item.
- 12 Item 1 concerns Docket 20-0722, which
- is Nicor Gas' request for approval of an
- 14 alternative rate regulation program under Section
- 15 9-244 of the Public Utilities Act for a new pilot
- 16 program that would allow Renewable Natural Gas
- 17 Production Facilities to interconnect with
- 18 Nicor's system and place into effect Rate 81,
- 19 which would provide allowances covering a portion
- 20 of RNG facilities' interconnection costs. On
- June 24th, the Commission issued an Order with
- 22 modifications to Nicor's filing. On June 28th,
- 23 Nicor filed a Notice of Acceptance with the
- 24 Commission, indicating its willingness to accept

- 1 the Commission's modifications to the tariff and
- 2 the Pilot. Consistent with Section 9-244(b) of
- 3 the Public Utilities Act, today's order is the
- 4 final order in this docket and recognizes that
- 5 Nicor has accepted the Commission's
- 6 modifications.
- 7 I am going to call a roll on this
- 8 vote. If you are in favor of approving the
- 9 Order, please say "Aye," and if you are opposed,
- 10 please say "Nay."
- 11 Commissioner Bocanegra?
- 12 COMMISSIONER BOCANEGRA: Chair, I'll
- 13 be voting nay consistent with my previous notes
- 14 on this matter. Thank you.
- 15 CHAIR ZALEWSKI: Commissioner
- 16 Carrigan?
- 17 COMMISSIONER CARRIGAN: Aye.
