CHAIRMAN ZALEWSKI: Good morning. I have 1 2 10:30. I'm going to go ahead and start. 3 Are we ready to proceed in 4 Springfield? 5 THE CHIEF CLERK: Yes, we are. 6 CHAIRMAN ZALEWSKI: Thank you. 7 Under the Open Meetings Act, I 8 call the September 13th, 2019, Special Open Meeting 9 to order. Commissioners Bocanegra, Oliva, Kimbrel, and Sheahan are with me in Chicago. We have a 10 11 quorum. 12 We have no requests to speak. 13 We'll move on to our Public Utilities 14 Agenda. There are no minutes to approve. 15 On our Electric Items, there's one item on the Agenda. 16 17 Item E-1 concerns Docket 18-1772, which is ComEd's Revision to Rider Residential Real 18 19 Time Pricing Program or RRTP to establish a one-year 20 pilot program that would invite a limited number of 21 customers who are likely to save money under Rider RRTP to enroll on a risk-free basis during the term 22

of the pilot. This item will be held for a later 1 2 disposition. 3 There are no gas or 4 telecommunications items. 5 Moving on to our Water and Sewer Items, we have one item. 6 7 Item W-1 concerns Docket 18-0785, 8 which is Aqua Illinois' Petition for a Certificate of 9 Service Authority to Provide Water and Wastewater Services in Kane County. 10 11 The Order also approves the Asset 12 Purchase Agreement between Aqua and Fox River Water 13 Reclamation District which establishes the ratemaking 14 base for a skyline system and approves applicable 15 rates for the water and sewer services in Kane 16 County. 17 Are there any objections to approving the Order? 18 19 (No response.) 20 CHAIRMAN ZALEWSKI: Hearing none, the Order 21 is approved. 22 We have no Miscellaneous Items, no

Petitions for Rehearing.

We have two items under Other 2 3 Business. Item O-1 concerns a contract with 4 5 Liberty Consulting Group to review costs associated with the Peoples Gas System Modernization Program 6 7 or SMP in the Rider QIP as directed in Docket 16-0376. This item will be held for a later 8 9 disposition. 10 Item 0-2 concerns approval of the Procurement Administrator's recommendations 11 12 regarding the Illinois Power Agency's September 2019 solicitation of bids to sell Standard Energy 13 14 Products to Ameren Illinois Company, Commonwealth 15 Edison Company, and MidAmerican Energy Company pursuant to Section 16-111.5 of the Public Utilities 16 17 Act. 18 Are there any objections to approving the Procurement Administrator's recommendations on 19 20 selection of winning bids? 21 (No response.) 22 CHAIRMAN ZALEWSKI: Hearing none, the
