- 3 Chicago?
- 4 COMMISSIONER DEL VALLE: We're ready.
- 5 CHAIRMAN SCOTT: Very good. Good morning.
- 6 Pursuant to the provisions of the Open
- 7 Meetings Act, I now convene a Regular Open Meeting of
- 8 the Illinois Commerce Commission. With me in
- 9 Springfield are Commissioner Colgan and Commissioner
- 10 McCabe. With us in Chicago are Commissioner del
- 11 Valle and Commissioner Maye. I am Chairman Scott.
- 12 We have a quorum.
- Before moving into the agenda, according to
- 14 Section 1700.10 of Title 2 of the Administrative
- 15 Code, this is the time we allow members of the public
- 16 to address the Commission. Members of the public
- 17 wishing to address the Commission must notify the

- 21 Regular Open Meeting.
- 22 We also have one item of unofficial business
- 23 to address. We would like to welcome Shamira
- 24 Marshall. Shamira is a second year law student at

- 1 Loyola University Chicago School of Law and will be
- 2 externing for Commissioner Maye's office this
- 3 semester. She has a Bachelor of Science in Sports
- 4 Administration and a Minor in Business from Kent
- 5 State University. We want to welcome Shamira to the
- 6 Commission.
- 7 Commissioner Maye, did you want to add
- 8 anything to that?
- 9 COMMISSIONER MAYE: I think you got
- 10 everything.
- 11 CHAIRMAN SCOTT: All right.
- 12 COMMISSIONER MAYE: We are even standing up,
- 13 so thank you for that.
- 14 CHAIRMAN SCOTT: Very good. Thank you.
- 15 Welcome, Shamira.
- 16 (The Transportation portion of the
- 17 proceedings was held at this time
- and is contained in a separate
- 19 transcript.)
- 20 CHAIRMAN SCOTT: Turning now to the Public
- 21 Utility Agenda. Item 1 is the approval of minutes

- 4 under ComEd's Rider EDA and Ameren's power
- 5 procurement riders, with actual costs associated with
- 6 programs and expenditures.
- 7 Is there any discussion?
- 8 (No response.)
- 9 CHAIRMAN SCOTT: Is there a motion to enter
- 10 the Orders?
- 11 COMMISSIONER COLGAN: So moved.
- 12 CHAIRMAN SCOTT: Is there a second?
- 13 COMMISSIONER McCABE: Second.
- 14 CHAIRMAN SCOTT: Moved by Commissioner
- 15 Colgan; second by Commissioner McCabe.

- We will use this five to nothing vote for

- 1 the remainder of today's Public Utility Regular Open
- 2 Meeting Agenda unless otherwise noted.
- 3 Item 4 is Docket Number 13-0589. This is
- 4 our investigation into the customer refunds by ComEd
- 5 for payments made under invalidated riders. The
- 6 parties have entered into a Stipulation and
- 7 Memorandum of Agreement. ALJ Sainsot recommends
- 8 entry of an Order approving those agreements.
- 9 Is there any discussion?
- 10 (No response.)
- 11 CHAIRMAN SCOTT: Any objections?
- 12 (No response.)
- 13 CHAIRMAN SCOTT: Hearing none, the Order is
- 14 entered.
- 15 Item 5 is Docket Number 07-0566. This is
- 16 ComEd's proposed general increase in electric rates.
- 17 On February 23, 2012, the Commission entered an Order
- 18 on Remand which directed ComEd to pay to customers a
- 19 refund of \$36.7 million, with interest, over an
- 20 eight-month period. On September 3, 2014, the
- 21 Commission reopened the matter and the parties seek
- 22 to resolve it at the same time as Docket Number
- 23 13-0589. ALJ Haynes recommends entry of a Second
- 24 Order on Remand accelerating the timing of the

- 1 refund.
- 2 Is there any discussion? Commissioner
- 3 McCabe.
- 4 COMMISSIONER McCABE: I have a question for
- 5 the ALJ. It appears the Stipulation and MOA requires
- 6 ComEd to set aside \$2 million, roughly, for refunds
- 7 for former customers. And ComEd Exhibit 61 on
- 8 remand, page 10, says that former customers must
- 9 submit a valid application to be eligible.
- 10 Is there anything in the record that
- 11 suggests that the Company will attempt to contact
- 12 former customers to inform them of their possible
- 13 eligibility?
- JUDGE HAYNES: I think the Company intends
- 15 to put a notice in newspapers. The newspapers and
- 16 then also a notice in the delivery service bills.
- 17 And that was in the testimony remand in ComEd Exhibit
- 18 60, not the new ComEd testimony that was submitted
- 19 for this agreement. But I don't think they intend to
- 20 track down former customers at all.
- 21 COMMISSIONER McCABE: Okay. Thank you.
- 22 CHAIRMAN SCOTT: Any further discussion?
- 23 (No response.)
- 24 CHAIRMAN SCOTT: Are there any objections to

- 1 the Second Order on Remand accelerating the timing of
- 2 the refund?
- 3 (No response.)

- I would like to propose a different
- 12 recommendation and Order. Regardless of whether the
- 13 Commission still has jurisdiction over the entity in
- 14 question, a copy of TelNet's 2013 Annual Report,
- which they were obligated to file under Section 5-109
- of the Public Utilities Act for the months of 2013 in
- 17 which they retained their certificates has been
- 18 received by the Chief Clerk's office. The Commission
- 19 retains copies of the reports, and in the event an
- 20 entity outside of the Commission requested a copy of
- 21 that report, it would not be protected without
- 22 granting the petition.
- 23 It appears that TelNet's report contains
- 24 "highly proprietary and confidential commercial and

- 1 financial information, the disclosure of which to
- 2 competitors, or potential competitors, would be
- 3 detrimental to TelNet," and thus, it is my position
- 4 that they meet the requirements under Section 200.430
- 5 of the Commission's Rules of Practice, 83 Illinois
- 6 Administrative Code 200.430, and Section 7 of the
- 7 Illinois Freedom of Information Act, 5 ILCS Section
- 8 140, Section 7(g), to have their 2013 Annual Report
- 9 protected from disclosure for a period of two years.
- 10 With that, I move to enter the Order
- 11 granting the Petition for Confidential Treatment.
- 12 Is there a second?

- 6 franchise agreement with the City of Chicago, and
- 7 that agreement has expired. It expired as of March,
- 8 is that correct? That's what I have --
- 9 JUDGE RILEY: Yes.
- 10 COMMISSIONER DEL VALLE: And so there is no
- 11 connection between authorization and franchise
- 12 agreements? They're totally separate?
- JUDGE RILEY: That's my understanding,
- 14 absolutely.
- 15 COMMISSIONER DEL VALLE: Since we grant
- 16 authorization, do we deal with consumer complaints as
- 17 a Commission?
- JUDGE RILEY: I don't -- I don't believe
- 19 there's any --
- 20 COMMISSIONER DEL VALLE: That's no role in
- 21 that at all?
- JUDGE RILEY: None.
- 23 COMMISSIONER DEL VALLE: But in the process
- 24 of providing that authorization, do we obtain any

- 1 information in the application process regarding
- 2 consumer complaints?
- JUDGE RILEY: We don't.
- 4 COMMISSIONER DEL VALLE: This is a mere
- 5 formality that doesn't mean a whole lot.
- JUDGE RILEY: That's exactly right.
- 7 COMMISSIONER DEL VALLE: And it has to be
- 8 done within 30 days of application.
- 9 JUDGE RILEY: Staff just has to determine if
- 10 it's a completed application. There's no other --
- 11 nothing else involved in the process.
- 12 COMMISSIONER DEL VALLE: Nothing at all? We
- 13 have no authority at all?
- JUDGE RILEY: No.
- 15 COMMISSIONER DEL VALLE: Other than
- 16 authorizing?
- JUDGE RILEY: Right. Exactly.
- 18 COMMISSIONER DEL VALLE: Okay. Thank you.
- 19 CHAIRMAN SCOTT: Any further questions?
- 20 Further discussion?
- 21 (No response.)
- 22 CHAIRMAN SCOTT: Any objections to the
- 23 Order?
- 24 (No response.)

- 1 CHAIRMAN SCOTT: Hearing none, the requests
- 2 are granted.

- 5 tariff changes related to rate design. Ameren has
- 6 filed a request for oral argument on the Proposed
- 7 Order's adoption of Staff's rate design, which ALJ
