- 2 CHAIRMAN SCOTT: Pursuant to the provisions of

- 4 scheduled Bench Session of the Illinois Commerce
- 5 Commission. With me in Springfield are Commissioner
- 6 Colgan and Commissioner McCabe. With us in Chicago
- 7 are Commissioner O'Connell-Diaz and Commissioner
- 8 Ford. I am Chairman Scott. We have a quorum.
- 9 Before moving into the agenda,
- 10 according to Section 1700.10 of Title II of the
- 11 Administrative Code, this is the time we allow
- 12 members of the public to address the Commission.
- 13 Members of the public wishing to address the
- 14 Commission must notify the Chief Clerk's Office at
- 15 least 24 hours prior to the Commission meetings.
- 16 According to the Chief Clerk's Office, we have no
- 17 requests to speak at today's Bench Session.
- We will start with the Transportation
- 19 agenda. We have only one item for consideration
- 20 today and it is a railroad item. Item RR-1 is
