- 1 PROCEEDINGS
- 2 COMMISSIONER EDWARDS: Pursuant to the
- 3 Open Meetings Act, I call the January 25th, 2017,
- 4 Regular Open Meeting to order.
- 5 On behalf of the Chairman and my fellow
- 6 Commissioners, I would like to take just a moment
- 7 to welcome our newest member of the ICC, Acting
- 8 Commissioner Oliva. Effective January 17th, 2017,
- 9 Governor Rauner appointed Sadzi Martha Oliva to a
- 10 five-year term.
- 11 Acting Commissioner Oliva comes to the
- 12 Commission from the Illinois Department of
- 13 Financial and Professional Regulation, where she
- 14 served most recently as General Counsel but also
- 15 previously served as Ethics Officer, Administrative
- 16 Law Judge, and Chief of Medical Prosecutions, and
- 17 also as Chief ALJ at the Illinois Department of
- 18 Children and Family Services.
- 19 Acting Commissioner Oliva earned a JD
- 20 from Loyola University School of Law and a BA from
- 21 DePaul University.
- Her appointment to the ICC has helped
- 23 us shatter yet another glass ceiling, as she is the
- 24 first Latina to serve in this role, which speaks to

- 1 our Governor's continued commitment to diversity.
- 2 Her arrival also makes this Commission, with now
- 3 three Latinos, one African-American, two women, and
- 4 one Irish-American, without a doubt, the most
- 5 diverse public utilities commission in the nation.
- 6 Please join me in welcoming Acting
- 7 Commissioner Oliva to the ICC.
- 8 (Applause)
- 9 ACTING COMMISSIONER OLIVA: Thank you.
- 10 COMMISSIONER EDWARDS: Commissioner
- 11 Rosales and Acting Commissioner Oliva are present
- 12 with me in Springfield. Commission del Valle is
- 13 present in Chicago. We do have a quorum. Chairman
- 14 Sheahan is participating by phone.
- Mr. Chairman, are you there?
- 16 CHAIRMAN SHEAHAN: I am. Thank you.
- 17 COMMISSIONER EDWARDS: Good morning.
- 18 CHAIRMAN SHEAHAN: Good morning.
- 19 COMMISSIONER EDWARDS: I move to allow
- 20 Chairman Sheahan to participate by phone. Is there
- 21 a second?
- 22 COMMISSIONER ROSALES: Second.
- COMMISSIONER EDWARDS: Any discussion?

- 13 week's Public Utility agenda. Therefore, we will
- 14 move on to our Electric items.
- 15 Item E-1 concerns ComEd's
- 16 revenue-neutral tariff changes related to rate
- 17 design.

- 21 COMMISSIONER EDWARDS: Hearing none,
- 22 the Resuspension Order is approved.
- 23 Item E-2 concerns CUB's Complaint
- 24 against ComEd regarding its 2015 AMI Implementation

- 1 Progress Report.

- As I stated when we first dismissed
- 16 this Complaint, the Commission has the
- 17 responsibility to take a close look and scrutinize
- 18 these expensive modernization programs on behalf of
- 19 the ratepayers and the General Assembly.
- For the last two years, the Company has
- 21 submitted AMI Plan Updates that covered the
- 22 implementation and results for investments that
- 23 total over one billion dollars, and the Commission
- doesn't even make a single comment on the

- 1 substance.
- 2 Based on this Order, the Commission
- 3 views its responsibility as merely determining
- 4 whether the plants -- plans are properly completed
- 5 and not whether they demonstrate an adequate level
- 6 of progress in implementing the expensive
- 7 modernization. The Commission is not applying an
- 8 appropriate level of engagement and scrutiny for
- 9 these programs.
- 10 In this docket, the Complaint raises
- 11 valid concerns regarding ComEd's AMI Plan and its
- 12 implementation.
- For reasons discussed in a dissent I
- 14 will be filing, I think this Complaint is wrongly
- 15 dismissed. Accordingly, I will be voting no on
- 16 this Order.
- 17 COMMISSIONER EDWARDS: Thank you,
- 18 Commissioner del Valle.
- 19 All those in favor of approving the
- 20 proposed Order dismissing the Complaint, say aye.
