- 3 of public convenience and necessity under section
- 4 8-406(a) of The Public Utilities Act.
- 5 On June 7, 2023 GridLiance filed a motion in
- 6 this Docket seeking to strike portions of Ameren
- 7 Illinois' testimony that addressed section 8-406 B, of
- 8 The Public Utilities Act. On august 29, 2023, the ALJ
- 9 denied the motion, stating that the testimony is not
- 10 stricken to ensure the Commission has a complete record
- 11 on which to make its decision.
- 12 GridLiance subsequently filed a petition for
- 13 interlocutory review on September 19, 2023. Ameren
- 14 Illinois filed a response to the petition, GridLiance
- 15 then filed a reply to that response. Which, pursuant to
- 16 section 200.520(a) of the Commission's rules is not
- 17 expressly permitted unless a briefing schedule has been
- 18 set by the ALJ. GridLiance thus filed a motion for leave
- 19 to address the points raised by Ameren and Ameren's
- 20 response.
- 21 We will address this item with two votes.
- 22 First, the vote to address the motion for
