- 10 Senior Secured Notes for the purpose of refunding,
- 11 redeeming and/or refinancing outstanding evidences
- of indebtedness. ALJ Jones recommends entry of an

- 21 Hilliard recommends we reopen the proceeding and
- 22 enter an Order on Reopening granting the requested
