- 17 transcript and November 6th Regular Open Meeting
- 18 minutes as amended are approved.
- 19 Item 3 is our investigation of
- 20 standard terms for customer authorization of access
- 21 to interval usage data for non-billing purposes.
- 22 Staff recommends entry of an Order initiating the

- 1 proceeding to determine appropriate language for the
- 2 release of the information at issue.
- 3 Are there any comments? Commissioner
- 4 McCabe.
- 5 COMMISSIONER McCABE: This proceeding will
- 6 address customer authorization of access to their
- 7 electricity usage data for non-billing purposes.
- 8 Staff has proposed language by which customers can
- 9 authorize access to their electricity usage info and
- 10 recommends an expedited proceeding.
- I hope that all relevant parties are
- 12 involved including municipalities or their
- 13 representatives. As the initiating Order and staff
- 14 report point out, the related 13-0506 workshops
- included CUB, Elevate Energy, ICEA, Retail
- 16 suppliers, utilities, the AG and the City of
- 17 Chicago. Thank you.
- 18 CHAIRMAN SCOTT: Thank you, Commissioner.
- 19 Any other comments?
- 20 (No response.)
- 21 Is there a motion to enter the Order?
- 22 COMMISSIONER MAYE: So move.

- 1 CHAIRMAN SCOTT: Second?
- 2 COMMISSIONER McCABE: Second.
- 3 CHAIRMAN SCOTT: It's been moved by Commissioner
- 4 Maye and seconded by Commissioner McCabe.
- 5 Any discussion?
- 6 (No response.)
- 7 All in favor, say aye.
- 8 (Chorus of ayes.)
- 9 Any opposed?
- 10 (No response.)
- 11 The vote is 5 to nothing and the Order
- 12 is entered.
- We will use this 5 to nothing vote for
- 14 the remainder of today's Regular Opening Meeting
- 15 agenda unless otherwise noted.
- 16 Item 4 is Docket No. 11-0592. This is
- our investigation into Ameren's compliance with the
- 18 efficiency standard requirement of Section 8-103 of
- 19 the Public Utilities Act. ALJ Sainsot recommends
- 20 entry of an Order finding Ameren achieved its Energy
- 21 Savings Goal and Peak Demand Response Reduction Goal
- 22 for its Plan Year Three.

- 1 Is there any discussion?
- 2 (No response.)
- 3 Any objections?
- 4 (No response.)
- 5 Hearing none, the Order is entered.
- 6 Item 5 is Docket No. 12-0560. This is
- 7 Rock Island Clean Line's Petition for an Order
- 8 authorizing a Certificate of Public Convenience and
- 9 Necessity pursuant to Section 8-406 of the Public
- 10 Utilities Act as a Transmission Public Utility and
- 11 to Construct, Operate and Maintain an Electric
- 12 Transmission Line and Authorizing and Directing Rock
- 13 Island pursuant to Section 8-503 of the Public
- 14 Utilities Act to Construct an Electric Transmission
- 15 Line. ALJ Jones recommends entry of an Order
- 16 granting the certificate, subject to conditions.
- 17 I have several edits I would like to
- 18 propose. First, I would like to thank Commissioners
- 19 McCabe and del Valle's offices for their assistance
- 20 in putting these together. These edits do not
- 21 change the conclusion to grant Rock Island the
- 22 Certificate of Public Convenience and Necessity, but

- 1 instead further clarify the Commission's position on
- 2 a few of the contested issues.
- 3 (1) The first set of edits can be
- 4 found on Pages 26-29 and address the concept of
- 5 "public use" within the context of a Section 8-406
- 6 proceeding. ComEd and others raise the argument
- 7 that Rock Island Clean Line is not building the
- 8 project for "public use" but for the private use of
- 9 the parties who are contracting to utilize the line.
- 10 These edits further define public use as it is
- 11 defined in case law and bolster the conclusion that
- 12 the line is indeed for public use, given that all
- 13 parties will have an equal opportunity to purchase
- 14 transmission on the project.
- The edits further support the
- 16 conclusion that if Rock Island is obligated to
- 17 expand its transmission service because the line
- 18 becomes over-subscribed, this CPCN will not cover
- 19 that expansion and they will be required to come
- 20 back and request additional approvals from the
- 21 Commission.
- 22 (2) The second set of edits can be

- 1 found on Pages 115-122. These edits address the
- 2 least cost issue and set out some of the case law
- 3 related to the public convenience and necessity
- 4 assessment that the Commission utilized in other
- 5 similar 8-406 proceedings.
- In addition, the edits make a finding
- 7 on the "lease cost" issue, which the Order
- 8 previously did not directly address. The edits make
- 9 clear that if Rock Island is short of funds for the
- 10 project and goes to FERC to recover the remainder of
- 11 the cost of construction from ratepayers, that their
- 12 certificate is no longer valid and that they will
- 13 need to come back to the Commission for additional
- 14 authority on that basis.
- 15 Finally, a portion of these edits
- which are proposed jointly with Commissioner
- 17 del Valle's office, incorporate evidence in support
- 18 of the Project's stated goal to bring high capacity
- 19 wind from the Resource Area into Illinois.
- 20 (3) The third set of edits can be
- 21 found on Pages 154-155. These edits attempt to
- 22 better address the financing condition and whether

- 1 Rock Island has satisfied its requirement. The
- 2 edits incorporate the argument that Staff raised in
- 3 its RBOE regarding ComEd, ILA and IAA's failure to
- 4 read the statutory language of the financing
- 5 requirement as a whole, essentially ignoring the
- 6 fact that whether Rock Island has proven it has the
- 7 capability to finance the Project is to be taken in
- 8 the context of avoiding harm to the utility or its
- 9 customers.
- 10 Additionally, they address the
- 11 Commission's desire to apply the statutory
- 12 requirements in such a way as to not preclude
- 13 merchant projects from being considered on the basis
- of their unique business model, which is by nature
- 15 different from that of an IOU.
- 16 Finally, these edits change the filing
- 17 requirement from Rock Island from a petition to a
- 18 compliance filing. A petition is an unnecessary
- 19 burden on the Petitioner, as well as Staff and the
- 20 other parties while a compliance filing satisfies
- 21 the Commission and ComEd's desire for a formal
- 22 review of the financing documents to be submitted by

- 1 Rock Island without causing undue delay.
- 2 (4) The final set of edits can be
- 3 found in the section on Landowner Concerns about
- 4 Impacts of Construction and appear primarily on
- 5 Pages 205-211. These edits relocate the Commission
- 6 conclusions which were scattered throughout the
- 7 summaries of parties' positions and also make
- 8 changes to be consistent with some points made in
- 9 Rock Island's BOE.
- 10 With that, I will move for adoption of
- 11 these edits. Is there a second?
- 12 COMMISSIONER del VALLE: Second.
- 13 CHAIRMAN SCOTT: It's been seconded by
- 14 Commissioner del Valle.
- Is there any discussion on the edits?
- 16 (No response.)
- 17 All in favor, say aye.
- 18 (Chorus of ayes.)
- 19 Any opposed?
- 20 (No response.)
- The vote is 5 to nothing and the edits
- 22 are adopted.

- 1 Is there now a motion to enter the
- 2 Order as amended?
- 3 COMMISSIONER del VALLE: So move.
- 4 CHAIRMAN SCOTT: Is there a second?
- 5 COMMISSIONER MAYE: Second.
- 6 COMMISSIONER SCOTT: Moved by Commissioner
- 7 del Valle and seconded by Commissioner Maye.
- 8 Any further discussion?
- 9 Commissioner McCabe.
- 10 COMMISSIONER McCABE: Rock Island Clean Line is a
- 11 merchant DC transmission line. It is a first for
- 12 the ICC. As the record attests, there's debate
- 13 about whether Rock Island should be a Public Utility
- 14 given the possibility of eminent domain authority
- 15 debate about its cost-effectiveness, whether it's
- 16 "needful and useful" and whether it promotes an
- 17 effectively competitive market.
- 18 With the Chairman's edits and staff
- 19 recommendations, this Order puts in place
- 20 requirements and safeguards that will insure (1)
- 21 that the line is built with secured financing and
- 22 (2) that investors, not ratepayers, bear the

- 1 financing costs and that Rock Island must return to
- 2 the Commission to make any changes.
- 3 The Order also requires that Rock
- 4 Island go to great lengths to offset impacts on
- 5 landowners, especially farmers. With that, I
- 6 support the Order.
- 7 CHAIRMAN SCOTT: Commissioners, are there any
- 8 further comments or discussion?
- 9 (No response.)
- 10 All in favor of the Order as amended,
- 11 say aye.
- 12 (Chorus of ayes.)
- Any opposed?
- 14 (No response.)
- The vote is 5 to nothing and the Order
- 16 as amended is entered.
- 17 And thanks to Judge Jones on the case
- 18 law work on this particular case. I'm very grateful
- 19 for that.
- 20 Item 6 is Docket No. 13-0476. This is
- 21 Ameren's filing for revenue neutral tariff changes
- 22 related to its rate design. A final Order was

- 1 entered in this proceeding on March 19, 2014,
- 2 however, the Attorney General subsequently filed a
- 3 motion for clarification identifying errors in the
- 4 description of its position. ALJ Von Qualen
- 5 recommends entry of an Amendatory Order correcting
- 6 the identified errors.
- 7 Is there any discussion?

- 10 (No response.)
- 11 Hearing none, the Amendatory Order is
- 12 entered.
- 13 Item 7 is Docket No. 14-0312. This is
- 14 ComEd's annual formula rate update and revenue
- 15 requirement reconciliation under Section 16-108.5 of
- 16 the Public Utilities Act. ALJ Haynes and
- 17 Teague-Kingsley recommend entry of an Order
- 18 approving the reconciliation and delivery service
- 19 rate increase.
- This item is being held for
- 21 disposition at a future Commission proceeding.
- Do we need an update on public

- 1 comments?
- JUDGE WALLACE: We can do that at the end,
- 3 Chairman.
- 4 CHAIRMAN SCOTT: Okay. Thank you.
- 5 Item 8 is Docket No. 14-0317. This
- 6 is Ameren's Rate MAP-P Modernization Action
- 7 Plan Pricing Annual Update Filing. ALJs Albers
- 8 and Von Qualen recommend entry of an Order approving
- 9 the reconciliation and delivery service rate
- 10 increase.
- 11 This item is also being held for
- 12 disposition at a future Commission proceeding.
- 13 Item 9 is Docket No. 14-0605. This is
- 14 Dorothy Appiah, DKY Developers' complaint against
- 15 ComEd as to billing/charges in Chicago. It appears
- 16 the parties have settled their differences and filed
- 17 a Joint Stipulation and Motion to Dismiss. ALJ
- 18 Kimbrel recommends that we dismiss the docket with
- 19 prejudice.
