- 8 from -- pension fund. They allocated (indecipherable)
- 9 supplemental order granting the requested relief.
- 10 Is there any discussion?
- 11 (No response.)
- 12 CHAIRMAN SCOTT: Any objection?
- 13 (No response.)
- 14 CHAIRMAN SCOTT: Agreed on the supplemental order
- 15 is entered.
- 16 Items RR-4 and RR-5 can be taken together.
- 17 These items are stipulated agreements for public safety
- 18 improvements at highway railroad crossings in Stark and
- 19 Shelby County.
- 20 Petitioners -- petitions have been filed
- 21 requesting additional time for funding. In both cases,
- 22 our transportation counsel recommends entry of a
- 23 supplemental order granting the requested relief.

- 18 We have one administrative article for

- 20 Urbana, the City of Champaign, and the County of
- 21 Champaign, joint petition seeking authorization to
- 22 construct a highway bridge in Champaign County.
- 23 Intervenor, Preserve Olympian Farmland, has filed a
- 24 petition for interlocutory review of a hearing of the
- 25 examiner's ruling.

1 Although this item will be held for 2 disposition at a future Commission proceeding, I would 3 note that the petition concerns evidentiary issues, which may impact parties' presentation of their cases 4 5 and witness testimony and cross-examination. 6 Thus, I would urge the ALJ to stay any pending 7 hearings, including today's, until such time as the Commission has had a full opportunity to review the 8 petition involved and evidence and issue its decision. 9 10 Any further comments on that matter? 11 (No response.) 12 CHAIRMAN SCOTT: Is there any further transportation business to come before the Commission 13 14 today? 15 COMMISSIONER MAYE: No. 16 COMMISSIONER COLGAN: No, Chairman. 17 CHAIRMAN SCOTT: Okay.
