1	PROCEEDINGS
2	CHAIRMAN SCOTT: Pursuant to the provisions of
3	the Open Meetings Act, I now convene a regularly
4	scheduled Bench Session of the Illinois Commerce
5	Commission. With me in Springfield are Commissioner
6	Colgan and Commissioner McCabe. With us in Chicago
7	are Commissioner Ford and Commissioner
8	O'Connell-Diaz. I am Chairman Scott. We have a
9	quorum.
10	Before moving into the agenda,
11	according to Section 1700.10 of Title II of the
12	Administrative Code this is the time we allow members
13	of the public to address the Commission. Members of
14	the public wishing to address the Commission must
15	notify the Chief Clerk's Office at least 24 hours
16	prior to Commission meetings. According to the Chief
17	Clerk's Office we have one request to speak at
18	today's Bench Session. The request today comes from
19	Gary and Debbie Davidson.
20	(Whereupon the Commission heard
21	the aforementioned public
22	comments.)

- 2 comment portion of today's agenda. We will begin
- 3 today with the Transportation agenda and the Railroad
- 4 section.
- 5 Item RR-1 is Docket Number T12-0123.
- 6 This items concern a petition for the authorization
- 7 of safety improvements at a crossing in Christian
- 8 County. ALJ Duggan recommends entry of an Order
- 9 authorizing the reconstruction project.
- 10 Is there any discussion?
- 11 (No response.)
- 12 Is there a motion to enter the Order?
- 13 COMMISSIONER COLGAN: So moved.
- 14 CHAIRMAN SCOTT: Is there a second?
- 15 COMMISSIONER McCABE: Second.
- 16 CHAIRMAN SCOTT: It's been moved and seconded.
- 17 All in favor say aye.
- 18 COMMISSIONERS: Aye.
- 19 CHAIRMAN SCOTT: Any opposed?

- 21 The vote is five to nothing, and the
- 22 Order is entered.

- We will use this five to nothing vote
- 2 for the remainder of today's Transportation agenda,
- 3 except where otherwise noted.
- 4 Items RR-2 through RR-4 (T11-0057,
- 5 T11-0060, T09-0092) can be taken together. These
- 6 items are stipulated agreements for public safety
- 7 improvements at highway-rail grade crossings across
- 8 Illinois. In each case Staff recommends entry of a
- 9 Supplemental Order granting additional time or
- 10 funding for the project's completion.

- 16 Moving on to Motor Carriers, Items
- 17 MC-1 through MC-3 can be taken together. These items

- 20 Transportation counsel recommends entry of an Order
- 21 accepting the Stipulated Settlement Agreement with
- 22 respect to the alleged violation.

12	together, and these items all concern applications
13	for licensure to operate as a recovery agency, a
14	recovery manager, a repossessor of collateral or a
15	recovery agent intern. In each case the ALJ
16	recommends entry of an Order granting the
17	application.
