- 18 of today's Agenda. Item E-1 concerns commencing a
- 19 reconciliation proceeding involving Mt. Carmel Public
- 20 Utility Company over revenues collected under fuel
- 21 adjustment charges. Staff recommends entry of an
- 22 Order commencing the proceeding.

- 19 MidAmerican to update its Rider 12, Nuclear
- 20 Decommissioning Factor to retain the existing rate of
- 21 zero cents per kilowatt hour. Staff recommends
- 22 approving the Company's request by not suspending the

- 1 filing.
- 2 Is there any discussion?

- 13 Item E-4 is Docket Nos. 11-0279 and
- 14 11-0282 consolidated. This is the rate cases for
- 15 Ameren's electric and gas operations and before us
- 16 today is the Company's motion to sever the electric
- 17 docket from the gas docket and dismiss the electric
- 18 proceeding. This matter will also be held for
- 19 disposition at a future Commission proceeding.
- 20 Either ALJ Yoder or Albers, are there
- 21 any public comments that we need to take mind of?
- JUDGE ALBERS: Yes. We would just let you know

- 1 that yesterday and this morning the Commission
- 2 received 256 letters asking the Commission to deny
- 3 the motion to sever and terminate the electric
- 4 docket.
- 5 CHAIRMAN SCOTT: Thank you.

- 7 together. These items are Applications for Licensure
- 8 as an Agent, Broker and Consultant under Section

- 7 Item G-5 is Docket No. 11-0046. This
- 8 is the AGL-Nicor merger case and ALJ Gilbert
- 9 recommends entry of an Order approving the
- 10 reorganization subject to the conditions identified
- in the Appendix to the Order.
- 12 Commissioner O'Connell-Diaz, I believe
- 13 you have some revisions you'd like to introduce here?
- 14 COMMISSIONER O'CONNELL-DIAZ: Thank you,
- 15 Mr. Chairman.
- 16 First of all, I'd like to thank all
- 17 the parties that were involved in this docket as well
- 18 as Judge Gilbert for giving the Commission a clear
- 19 record and a good Order. With that said, there's
- 20 some changes -- three changes that I have proposed to
- 21 enhance this Order. And this is to address some
- 22 concerns relative to the fact that the Company that

- 1 is going to be the successor entity is, in fact, an
- 2 out-of-state company at this point in time. And in
- 3 order to, you know, keep things going forward in
- 4 Illinois, we felt it was -- or I should say, I felt
- 5 it was important to have these changes reflected in
- 6 the Order to ensure appropriate Illinois
- 7 representation.
- 8 The first change that I have proposed,
- 9 and it has been circulated among my colleagues, is
- 10 that we note that under the provisions of the Act the
- 11 Commission has a longstanding policy that we
- 12 encourage Illinois-regulated entities to be involved
- in the economic development and social programs in
- 14 our communities. And based on this rationale, the
- 15 Commission finds it reasonable and in fulfillment of
- 16 those goals that the Joint Applicants by committed to
- 17 maintaining Nicor Gas's proactive stance on economic
- 18 development within Illinois.
- In furtherance of this requirement, we
- 20 direct that the Joint Applicants continue such
- 21 activities at a minimum level that Nicor Gas
- 22 currently commits to the various social and

- 1 charitable programs throughout the Illinois service
- 2 territories.
- Additionally, this does not presume
- 4 the reasonableness of those expenses that would be
- 5 put forth in a rate proceeding and they would go
- 6 under the same scrutiny that would normally occur
- 7 under the Section 9-227 analysis.
- 8 The second change has to do with the
- 9 fact, again, that this Company's going to be --
- 10 certainly not -- you know, certainly within our
- 11 purview, but they will be managed from a distance.
- 12 And so what we have come up with -- or I should I
- 13 have suggested to my colleagues -- is a direction to
- 14 AGL that as long as it owns, controls or manages
- 15 Nicor Gas or a successor entity, it shall have at
- 16 least one non-employee individual resident of
- 17 Illinois on AGL's Board of Directors. AGL shall have
- 18 the sole discretion in selecting such qualified
- 19 candidates. We find that this requirement will
- 20 further satisfy the spirit and the goals of the
- 21 provisions of the Act by ensuring that the AGL Board
- of Directors includes a member having firsthand

- 1 knowledge of the issues and concerns unique to
- 2 Illinois utilities and their customers.
- 3 And the third and final requirement or
- 4 condition is that in order that the Commission be
- 5 apprised of the compliance of AGL of the many
- 6 commitments that are reflected throughout the Order
- 7 as well as Appendix A, the Commission directs that
- 8 the CEO of AGL on an annual basis shall appear before
- 9 the Commission to report on the status of its
- 10 compliance with this Order.
- 11 And we have circulated this. I have
- 12 had some good additions from the Chairman's Office
- 13 with regard to the initial stab at this language, and
- 14 I thank his Office for that. And so I would leave it
- 15 to my colleagues to support these revisions. They
- 16 would be reflected in the Appendix A as separate
- 17 entries on that Appendix A. And those have been
- 18 circulated to all the Commissioners.
- 19 Thank you.
- 20 CHAIRMAN SCOTT: Thank you, Commissioner.
- 21 Would you move then for adoption of
- 22 the revisions?

- 1 COMMISSIONER O'CONNELL-DIAZ: I would move for
- 2 the adoptions of these wonderful revisions.
- 3 CHAIRMAN SCOTT: I will second that motion.
- 4 Is there any further discussion on the
- 5 revisions?

- 8 say, Aye.
- 9 (Chorus of ayes.)

- 2 (Chorus of ayes.)
- 3 CHAIRMAN SCOTT: Any opposed?

- 6 the Order as amended is adopted.
- 7 And thank you to all the offices to
- 8 the parties as well as to Judge Gilbert who -- I
- 9 second what Commissioner O'Connell-Diaz said -- did a
- 10 fine job on that for all the hard work. So thank you
- 11 very much, Judge -- who's kind of hiding in the
- 12 background. So thank you very much, Judge.
- 13 COMMISSIONER FORD: Thank you.
- 14 CHAIRMAN SCOTT: Moving on to Item G-6 is
- 15 Docket Nos. 11-0280 and 11-0281 consolidated. This
- 16 is the Peoples and North Shore Gas rate case. As
- 17 previously noticed to the parties, we will be holding
- oral argument in this matter on Tuesday,
- 19 December 13th at 1:15 p.m. in the Commission's
- 20 Chicago offices.
- Item G-7 is Docket No. 11-0679. This
- 22 is Glacial National Gas's Application for a

- 1 Certificate of Service Authority to operate as an
- 2 alternative gas supplier. ALJ Wallace recommends
- 3 entry of an Order granting the requested certificate.
- 4 Is there any discussion?
